Environment and Transportation Department

Control of Stationless On-Street Bicycle Hire Bye-Laws

Moby have a fleet of 140 electric bikes available for public hire. Bleeper continue with their successful operations with over 800 bikes now available for public hire. Both operators have provided free bikes for healthcare workers throughout 2020/2021 and this is continuing in 2022. The ongoing roll out of additional bike parking continues which will facilitate the expansion of stationless bike operations. Stands to accommodate an extra 554 bikes were installed during 2021. Bleeper's membership increased from 76,000 at the end of 2020 to currently stand at over 110,000. Q3 usage was over 119,000 individual journeys. Bleeperbike users cycled over 950,000km in 2021 saving the equivalent of 137 tonnes of carbon and were cycled for over 275,000 hours in 2021. Research is ongoing regarding integration/interoperability options with other mobility/transport services. A review of operations is currently being undertaken and it is anticipated that the maximum number of bike permits available to each operator will be increased to 1,500 each in Q3 2022 with additional bikes en route. Bleeper recently launched a trial 24/7 service to facilitate demand from late night and shift workers and have also launched a new more user friendly App which has been hugely sucessful.

E-Cargobikes for Business Pilot

Dublin City Council and bike sharing operator Bleeper are progressing well on the e-cargobike for business pilot project. The project gives businesses access to e-cargobikes at a discounted rate, enabling them to replace trips which would otherwise have been taken by car or by van. The pedal-assist electric cargobikes are available to businesses at a discounted rate of €100 per month. The bikes have a cargo carrying capacity of 60kg, with a battery which can last for up to 160km and can be fully recharged in 6 hours. The project has been so successful that an extension of the project has been agreed. The timeframe has been increased to allow for a further 10 opportunities to be provided to qualifying businesses. To date 17 e-cargobikes have been delivered to successful participants, and 34 businesses have made applications.

Parking Tag and alternative methods of paying for parking

Due to the Covid-19 Virus isolation, the number of transactions per week in April 2020 had reduced to 10,500 from a high of 126,155 earlier in 2020. The number of weekly transactions for week ending 14th November 2021 has risen to 102,535. Since the beginning of the Covid-19 situation, the numbers using the Parking Tag had dropped very significantly in line with the reduction of parking meter usage. The weekly revenue on average of €400,000 had reduced to €25,000 for Pay and Display parking in March and April 2020. However, the numbers using the Parking Tag have increased and by week ending 24th April 2022 that week's revenue was €279,545.79.

Car Clubs

In addition to the existing Car Club companies GoCar and Yuko operating within the Dublin City Council administrative area, a third company Enterprise Rent A Car has been licensed to operate in Dublin City from September 2021. This brings to three the number of car club companies operating in Dublin City and the total number of live Car Club permits currently issued is 419. As of 2022, management of the Car Clubs has been transferred to the Micromobility Unit.

Electric Vehicles

This is an area of active consideration for the Council and we remain aware of the transition to electric vehicles as set out in the Climate Action Plan as we prepare to respond to the needs of the citizens of the City by providing a sustainable urban mobility strategy. The Council is also aware that technology is changing rapidly and that a range of different solutions will be required to successfully address current and future mobility demand, not only in the City, but also across the wider Dublin Metropolitan Area. This requires careful consideration and planning to ensure that the Council can play their part to facilitate the provision of a comprehensive, reliable and interoperable electric vehicle-charging infrastructure. This is so that members of the public and business community can be confident in making decisions to purchase electric vehicles and to use electric vehicles for personal, leisure and business use, for use on both short and long journeys and to be more aware of the wider spectrum of mobility options now available and being planned for.

The commissioned EV charging strategy study will help inform the four Dublin local authorities of the type and number of chargers required across each council area as well as cost and resource requirements. This will allow us examine how the four Councils can best facilitate the provision of electric vehicle-charging infrastructure across the Dublin region and the scale of investment required.

Our consultants completed an industry stakeholder engagement piece late last year and the Dublin Local Authority Electric Vehicle Charging Strategy is now practically complete and is going through internal processes prior to finalisation. The DMA working group are now moving forward with the next steps of the project, which will include a procurement plan required for the roll out of the strategy in balance with the Council's wider sustainable mobility policies. However this will be subject to resources & availability of funding from the Department of Transport.

The SEAI scheme is currently being repurposed to take account of rapidly changing technologies and the realities of the business case and electrical infrastructure costs of public charging provision and the Council has fed into the new SEAI scheme for the provisioning of EV charge points in Multi Unit Dwellings (to be launched shortly).

A pilot off-street small scale public charging mobility hub is at works phase and it is planned to include charging for private EVs, car share clubs and eBikes beside a transport node. Charging at speeds of 22kw AC and 75kw DC are planned and data from usage will help inform future plans.

Claims Liaison Section

The Claims Liaison Section's primary objective is to assist Irish Public Bodies Insurance to effectively manage the investigation and defence of public liability and employee liability claims against Dublin City Council. The Section deals with claims spreading across Drainage, Roads Maintenance Division, Waste Management, Wastewater Services, Water Services, Public Lighting and Traffic Management. All employee claims from all departments against the Council are also investigated within the Section.

DCC is obliged under its contract for insurance with IPB to adhere to agreed protocols in liaising with IPB and their legal representatives. It is also in the public interest that the successful management and the best defence of claims against DCC is presented. The unit is also tasked with devising and overseeing risk strategy within the relevant sections to assist with a comprehensive programme of hazard identification and elimination. Assisting those Departments to identify the risk patterns and to devise controls and assist in putting such controls in place, supporting a proactive risk management strategy. The unit also liaises with IPB's Special Investigations Unit regarding possible fraudulent claims against DCC. Investigation and determination of cases continues throughout the Covid Restrictions and in 2021 the Section dealt with 537 new public liability cases 51 new employers liability claims.

Road Maintenance Services

Road Maintenance Services resolved approximately 1,850 customer enquiries and service requests during the period January to March 2022. Additionally, during the same period 1,679 defects and hazards on the road network were repaired and/or made safe by our direct labour crews. Furthermore, a total of 104 critical defects and hazards were repaired and/or made safe within 24 hours of being recorded. Road Maintenance Services has prepared its Annual Works Programme for 2022. The programme provides for the investment of €12 Million to upgrade 10km of road carriageways and 12.5km of footpaths. These works will be carried out from May through to November. Tender documents for the appointment of contractors are currently being prepared and tenders sought from contractors.

Bridges & Other Road Structures

Bridge Maintenance will commence preparation of tender documents for Principal Inspections in 2023. Special Inspections are underway on Butt Bridge and Matt Talbot Bridge and special inspections are being planned on three other bridges. Scour risk assessments are required on 10 other bridges. Bridge refurbishments and vegetation control are being planned.

Dublin Waste to Energy Community Gain Fund

The Dublin Waste to Energy Community Gain Fund Committee announced the 26 approved grant applications in respect of the Dublin Waste to Energy Community Gain Projects Grant Scheme 2021. A list of the successful grant applicants is detailed below.

Approximately €500K was allocated to a diverse range of projects representing a broad range of sectors including sports and recreation, arts, education and training and community. The Committee are confident that the projects selected will not only benefit the local communities of Irishtown, Ringsend and Sandymount but also enhance their local area and in doing so will provide the maximum opportunity to advance community, educational, recreational and environmental initiatives within the catchment area.

The Committee received 45 grant applications requesting grant assistance totalling circa €1.6 million and as the total amount of grant funding available for allocation on this occasion was €500K the Committee had to decline many commendable applications submitted for consideration. Selecting grant recipients from an outstanding and varied group of applicants was an extremely challenging task and unfortunately the Committee did not have the funding available at this time to provide grant assistance to each worthy applicant.

Waste Services Update

Street Grading

360 surveys were undertaken on 311 streets across the six waste management areas in March 2022. Grading was mainly carried out between 9am and 1pm Monday to Friday. 68% of streets graded received a Grade A, 20% Grade B, 12% Grade C, 0% Grade D.

From 21st February a new policy is in place whereby should any streets be awarded a grade C or D, a CRM request will be issued to the relevant area supervisor to address the issue that resulted in the poor grade.

Recycling Services

Parks & Landscaping Services have now issued a request for tender for the proposed refurbishment of the Eamon Ceannt Park depot and adjoining Bring Centre. Proposed works are due to begin in May following appointment of the successful contractor. The works will take approximately six months and the Bring Centre will be closed for the duration. Bottle and textile banks will be temporarily placed on the path outside the bring centre for the duration of works.

Waste Management Services continue to work with Dublin based artist collective, Creative Connections and the relevant Area Offices to animate bottle banks in highly visible and/or problematic locations. Work has recently been completed at Walkinstown Green, Tonlegee Road and East Road. Work is also ongoing on repainting a number of bottle banks in storage when weather permits with a view to replacing unsightly bottle banks in public spaces over the coming months.

School Programmes

The Picker Pals Programme is an anti-litter initiative for primary schools from VOICE Ireland. The programme is funded by Dublin City Council and the Department of Environment, Climate and Communications. There are 82 classes within the Dublin City Council area taking part in this academic year. For more information, please visit www.pickerpalsworld.org.

The Composting for Schools Programme is a collaborative pilot project for the Dublin area from the four Dublin local authorities and the Eastern-Midland Regional Waste Office. 39 schools from the DCC area are participating. Teachers and other school staff took part in a series of training workshops to learn about composting. An expert from Composting Ireland is now visiting participating schools to help establish a composting system at the school.

The Green-Schools Programme continues to be delivered to primary and secondary schools throughout Dublin City Council. Environmental Awareness staff have now visited each school seeking to renew their Green Flag Award for the 2020-2022 academic period. Community Environment Action Fund

The completion deadline for projects funded under the previous 2019/2020 grant scheme was the 31st of December 2021. It is anticipated that a new scheme will be announced by the Department of the Environment, Climate and Communications in early 2022. Global Circular Economy Hotspot 2023 event to be held in Dublin.

We are delighted to announce that the Eastern & Midlands Regional Waste Management Planning Office (EMRWMP) in partnership with the Rediscovery Centre, Dublin City Council and Circuleire, was successful in winning a bid to host the Circular Economy Hotspot 2023 event in Dublin.

Now in its fifth year, the Circular Economy Hotspot has become a global flagship event on the circular economy calendar and has been previously hosted by the Netherlands, Scotland, Belgium, Luxembourg and Catalonia. In 2023, for the first time, Dublin will host the Hotspot alongside two other global regions: Lagos, Nigeria and Chile.

Hosting the European Circular Economy Hotspot in 2023 will bring international visibility to circular economic initiatives here in Ireland, and will create international opportunities for Dublin and the greater Dublin region. It will also provide a platform for Irish organizations keen to make the circular transition, creating a circular legacy for Irish citizens and businesses. Furthermore, through a programme of citizen engagement, Circular Economy Hotspot Dublin will aim to bring the circular economy to life, making it relevant to the day to day life of Dubliners.

The successful bid was led by the Rediscovery Centre and supported by 30 organizations from Government, Public-Sector, Industry, 3rd Level Education and Social Enterprise, including The Department of Environment, Climate and Communications, the Department of Rural and Community Development, the Department of Agriculture, the East-Midlands Regional Assembly and the Environmental Protection Agency.

Circle City Recycling Initiative

The Circle City recycling on the go initiative was launched on the 19th October 2020 with 25 recycling bins installed in the Grafton Street and Henry Street areas to facilitate recycling of plastic bottles and cans 'on the go' in the city centre. Waste audits of the installed bins are being carried out to assess the success of the initiative to date and the project is ongoing. Phase 2 of the project launched in November 2021 more than doubling units of recycling on the go bins and widening locations to neighbouring streets. An increased public awareness campaign will take place throughout March and April. Project review and report will be available from Hubbub in Q2 2022.

Housing Waste Recycling Project

The Housing Waste Project was suspended for the majority of 2021 due to ongoing Covid-19 restrictions. The project restarted in late November and inspections of housing and older persons' complexes in Ballyfermot/Drimnagh were conducted by Waste Management Services in tandem with Housing Maintenance and the relevant South Central Area Housing personnel. Inspections in this area are now completed and the introduction of brown and green bins to older persons' complexes and housing complexes where feasible will begin in Q2 2022.

Assessments of existing bins and bin areas in older person's complexes in Central, North Central and North West Areas will begin in Q2 2022.

Bulky Household Waste Collection Service

Dublin City Councils online bulky waste ordering system is now fully digital and customers can now request and pay for a service collection 24/7 as the entire process is fully automated through the Citizen Hub Platform. Customers can now complete the ordering process from beginning to end including making secure payment without the need to go through our customer services department.

There is no material change to the actual service itself, how it operates or cost. It has simply been improved and enhanced by allowing customers to access the service at any time of the day or night. https://citizenhub.dublincity.ie Customers can also access the form through our website Bulky Household Waste Collection Services | Dublin City Council

Our customer services centre will remain available between the hours of 9am and 5pm Monday to Friday to assist customers who want information about the service or who wish to place an order.

Dublin City Neighbourhoods Awards 2022 /IPB Pride of Place Competition

The City Neighbourhoods Awards 2022 will take place on the 6th October 2022 in Croke Park. Arrangements are in place for an area wide competition and groups have already shown their excitement by cleaning and planting their neighbourhoods. IPB Pride of Place have confirmed

that the 2021 awards will take place on 16th May in Killarney. Entries were Bloomin' Crumlin/Kimmage and Finglas Tidy Towns.

Team Dublin Clean-up

The Team Dublin Clean will take place on 30th April to coincide with the National Spring Clean month. This is the day where 80 to 100 groups from all over Dublin come together to clean-up Dublin. Arrangements are in place to distribute equipment and supplies to the groups and Waste Management Services will collect and dispose of the bags after the clean-up.

Plans are also in place this year to include the Liffey Sweeper, which is managed by the Irish Nautical Trust, and local rowing clubs to come together to clean the river Liffey.

Special Speed Limit Bye-Laws 2020

In regards to Phase 4 of the Special Speed Limit Bye-Laws 2020, DCC has completed the implementing of the 30km/h speed limit signage in residential areas as per the approved Phase 4 - Speed Limit Bye-Laws 2020.

Protection of Water Bodies

DCC is working to integrate a number of projects to ensure that the opportunities to meet DCC's Water Framework Directive (WFD) obligation of achieving "good" status for all our water bodies by 2027 are maximised. Current examples are:

- The Santry River Restoration and Greenway Project is a cross-agency, multidisciplinary project to produce a Masterplan, based on an options assessment, for the River Santry catchment in order to achieve the objectives set out in the Water Framework Directive, Floods Directive, Birds & habitats Directive and the Greater Dublin Area Cycle Network. DCC is preparing a brief on the Santry River to engage consultants as part of a URDF funded project to restore the river to a more natural state, and investigate and remedy sources of pollution. A restricted procedure to engage consultants is currently underway. Tender submissions were received by the 7th February 2022 and have been assessed. A successful candidate has been identified and letters of intention and regret are currently being prepared We anticipate having a design consultant appointed by April 2022. This project is in collaboration with Parks, Landscape Services & Biodiversity, as well as the Sustainable Transport and Projects Section of the Roads and Traffic Division. Fingal County Council and Inland Fisheries Ireland are very supportive of this scheme. Funding is mainly from the Urban Regeneration and Development Fund, and, in the case of the greenway, the National Transport Authority.
- The Protection of Water Bodies Office is progressing a pilot surface water management project using Green Infrastructure principles. We have appointed a Consultant to design (and bring to implementation stage) a number of nature based water retention measures using a sustainable urban design approach at nine different locations in the Dodder and Santry river catchments. These Sustainable Drainage

Systems (SuDS) are expected to have the dual effect of reducing the rate of surface water runoff into sewers/watercourses, thus reducing the risk of downstream and local flooding. Equally important is the expected outcome of improving the water quality through percolating the surface water runoff through this green infrastructure approach prior to entering the nearby watercourses. Conducive with our goals for Climate Action, this pilot project will greatly enhance biodiversity opportunities in the public realm. Our office continues to liaise with our colleagues in Environment and Transportation, in the Parks Department and in the City Architect's Office to facilitate the implementation of this approach in public realm projects.

- The Protection of Water Bodies Office has taken the role of Project Manager for the Culvert Improvement Works Screen Upgrade Works. The Successful Contractor has been identified from the tender process and it is anticipated this contract and the delivery of the construction stage of the project will take effect in guarter 2 of 2022.
- The Protection of Water Bodies Office presented the current Public Consultation on the Draft River Basin Management Plan to the Climate Action, Environment & Energy SPC on December 1st. This Public Consultation process is open until the 31st of March 2022 and is being managed by the Local Authority's Water Programme (LAWPRO) on behalf of the Minister. That presentation is now available to view from the DCC webcast online library and further details are available on www.catchments.ie and pertinent documents may be viewed on the website of the Department of Housing, Local Government & Heritage.

Bathing Waters

A Bathing Waters Task Force (BWTF) was established in 2019 and includes Dublin City Council, Dun Laoghaire Rathdown County Council, Fingal County Council, the DHPLG and Irish Water. The BWTF's remit is to identify potential sources of pollutants affecting bathing water quality in Dublin Bay and eliminate, or remediate, the source of the pollutants. The primary objective being to protect public health, including that of sea swimmers. An enhanced programme of water quality testing has identified a number of significant misconnections and areas for further investigation. Misconnection inspections were disrupted by Covid-19 restrictions however, the surveys are scheduled to re-commence fully in Q2 of 2022 following government and HSE advice. DCC continues to support and collaborate with taskforce stakeholders to ensure a coordinated approach to remove bathing water pressures is achieved.

The Protection of Water Bodies Office made a submission on behalf Dublin City Council to the ongoing public consultation on 'Bathing Water Quality – Review of EU Rules' (EU Bathing Water Directive 2006). That consultation process is open to all members of the public. A copy of the DCC submission was circulated to members of the Climate Action, Environment & Energy SPC.

The Water Pollution Control Section have been invited to present the 2021 Bathing Water Report at the next SPC meeting on 30th March 2022. The report was published in November 2021 to provide the public and elected members with a broad overview of bathing water performance and pressures in Dublin City.

Drainage Planning

In addition to providing drainage input on planning applications, including SHDs, we are advising on LAPs, SDZs and the City's New Development Plan. We are providing drainage input on major new infrastructure projects such as Metro, Bus Connects and various cycle schemes. We are assisting Irish Water with new planning applications/connection applications. The SuDS Working Group is now established with multi-disciplinary representation from Drainage, WFD, Roads, Climate Change, Parks, City Architects and Planning.

The Working Group agreed 3 new appendices to the new Development Plan which support policies in that plan. These cover:

- Surface Water Management Plans.
- SuDS guidance
- Green Blue Roofs policy.

Three new guidance documents have been introduced:

- SuDS Design and Evaluation Guide
- Green Blue Roofs Guide
- SuDS Retrofit Guide

Flood Defence

- Consultants have been appointed by DCC to investigate the reduction of flood risk across the DCC and SDCC sections of the River Camac. Environmental and topographical surveys are now completed. A computer model has been built to investigate tidal, fluvial and pluvial flood risks associated with the river. Preliminary flood extent maps are being verified.
- This study as with all other flood alleviation projects is being integrated into a desire to "de-culvert" and widen what is now seen as an over engineered river where possible so that it can, over time, be restored to a more natural state, as far as reasonably possible. The project will also involve identifying and remedying urban pollution sources, where possible. This is also being done in conjunction with an existing Greenway proposal and in tandem with Urban Regeneration and Development Fund (URDF) funded projects in the area. The new City Edge project gives opportunities to achieve some of this.

Climate Action Team

The Climate Action Team submitted an Expression of Interest for the EU Mission 100 Climate Neutral and Smart Cities on January 31st. The EU Mission has confirmed that Dublin City meets the eligibility criteria and our submission is being considered for participation in the Mission. The outcome of the selection process is to be announced in late April/early May. There were 377 submissions from cities across Europe.

The Climate Action Team is currently exploring the potential of participating in EU funding calls led by academia. Consideration is being given to projects that will further climate action. The Climate Action Team with EMRWMPO was involved in a bid for Dublin to be the 2023 Circular Hotspot. The application was led by the Rediscovery Centre and was successful.

The Climate Action Team's Creative Ireland funded project "Eat the Streets!" that was focused on food and climate change, was successfully completed. Next steps for the project are being considered in terms of a future annual event and potential for a food strategy. The Climate Action Team invited the public to complete the Edible Dublin: Food Strategy survey. The survey closed on February 14th with 362 responses. The next step is to analyse the responses and identify focus groups to explore ideas emerging from the survey responses.

DCC's application for the Creative Climate Action Fund was successful and we will be working with the Arts Office to implement this project which will engage residents of Crumlin.

DCC's application to participate in IURC was successful and we are partnered with Seoul, South Korea. This is an 18 to 24 month programme that will involve study exchanges with key stakeholders in the city of Seoul on the topics of climate change and COVID recovery. There have been three bilateral meetings with DCC staff and Seoul staff discussing active travel. Plans are underway for study visits to progress pilot actions that will be implement in Dublin and Seoul.

The Climate Action Team is involved in a stakeholder group feeding into the development Local Authority Climate Action Plan Guidelines by the EPA and MAREI.

The Climate Action Team is developing a plan for engaging communities on local climate action that will involve the area offices. It is envisaged that there will be workshops where councillors will be invited to attend to ensure meaningful engagement and collaboration with residents.

Climate Action Regional Office

CARO, the four Dublin Local Authorities and SMART Dublin are part of an EV Regional group. The group has an agreed strategy. The stakeholder engagement part of this strategy has been completed and discussions with the Dept. of Transport regarding funding and procurement support have taken place. The DoT have published a Draft Electric Vehicle Infrastructure Strategy which the CAROs and LA sector will be consulted.

Green procurement training with Greenville Procurement Partners Ltd., as the contractor is in the development stage. CARO is working with the contractor tailoring the training to suit local authority needs. Local authority case studies will be included. This training is following on from the Climate Action Charter 2019 whereby local authorities have pledged to implement green public procurement strategy and procedures across all business areas. Training in this area for local authority staff will commence in April. A half-hour introductory session for staff is planned for mid-April. The invitations will come through the local authority training officers.

CARO is continuing the roll out of the Local Authority Climate Action Training programme for local authority staff. It is organised into six training pillars on a grade/role basis. The training programme was developed by CARO in conjunction with the Local Authority Services Training Group and other expert partners such as Climate Ireland. Further information is available on the CARO website https://www.caro.ie/training-events/training

The 'Championing Leadership' Climate Action Training for senior management and elected representatives of DCC, FCC and SDCC and DLRCC have all taken place. The DLRCC session takes place on March 25th. The Dublin CARO Coordinator gave an opening presentation at the training sessions. There was a catch up opportunity to attend the 'Championing Leadership' pillar on 1st April for those who missed their earlier session which was well attended. The Actioning Policy pillar for training specialist groups e.g. planners in DCC will continue across 2022 and 2023.

CARO, in collaboration with Age Friendly Ireland is planning a series of Climate Action' workshops to take place during 2022. A hybrid model of in person and virtual workshops, beginning in May, is being planned. The procurement process is underway.

Línte na Farraige is one of the 15 successful Creative Ireland Climate Action fund projects, Dublin CARO collaborated with Local Authorities, artists and 3rd level institutes and other partners on this project. Two CARO staff are part of the project team. The potential sites have been selected in Fingal CC, Wexford CC, Galway CC and DLRCC. The sites, subject to approval by the local authorities and ministerial consent as they are national heritage and archaeological monuments, and subject to adequate funding. The illumination may be in place for up to six months. The proposed Línte installations will use illuminated LED horizontal lines to represent future sea-level and storm surges. An interactive website and community engagement activities will be part of the installation. Trialling the use of climate games in local schools to promote climate action and awareness is proposed as part of the Línte project. The project is progressing. A Línte *promotional* video is being developed and the installations are planned to be in place Q3 2022.

Creative Climate Action Crumlin is a series of climate projects to raise awareness, enhance the environment and change life styles. CARO's role in this project is setting out and verifying climate targets and synergies with the Climate Action Plan 2021 and CCAP. A project manager has been appointed through public procurement by the Dublin City Arts Office, who are responsible for the project overall. CARO attend the fortnightly working group meetings with DCC and other partners. The project budget has been agreed. The evaluation of behavioural change in the community will begin in 2022 with input of the Economic and Social Research Unit (ESRI). The project is ongoing.

The Dublin Gazette are running a Making Dublin Greener competition for primary schools over 8 weeks. The free gazette is available across the Dublin Metropolitan region. CARO have sponsored competition prizes for the spring Dublin Gazette 'Making Dublin Greener' competition for Dublin primary schools. https://dublingazette.com/news/digital-gazette/dublingazette-digital-edition-march-10-2022-2/

CARO are represented on a national technical advisory group to assist LAs in preparing new national guidance to prepare 'Climate Action Plans 'as per the requirement in the Low Carbon and Climate Action (Amendment) Act 2021. DCC and Codema are also represented

on this advisory group. This Draft Guidance is currently with DECC for agreement and wider circulation to the LA sector.

Dublin CARO prepared a response on behalf of the four CAROs nationally as a key stakeholder on the revised National Adaptation Framework (NAF). A full public consultation on the NAF is planned for April 2022 and the CARO will encourage LA Climate Team to make appropriate submissions.

The third Working group report of the Intergovernmental Panel on Climate Change (IPCC) was also released in April further underlining the urgent need for climate action across all sectors to reduce our emissions and adapt to the impact climate change is causing now and will continues to cause in the future.

CARO is collaborating on a Green Roof project with UCD. The purpose of the project is to investigate how effective green roofs are in decreasing storm water runoff from developments and the extent of flooding. Progress on this project has been delayed by COVID. It is proposed that Baseline data will be collated on public and private sector roofs over a period of one year with data being used to calculate water attenuation from a flood prevention perspective.

Dublin CARO is supporting Smart Cities Climate Action Data Challenge competition to use open data to promote and support climate action. The challenge was launched 30th March 2022. The close for applications is 25th April.

As an expert partner in the GAA Green Clubs programme, Dublin CARO took part in the GAA Green Clubs event in the Connaught Centre for Excellence in Mayo on 23rd March. It was the first face to face event help for clubs due to COVID and attendees viewed a range of sustainability measures such as photo voltaic solar panels, electric vehicle chargers, tree planting, grey water recycling and waste management were on display.

Further updates and events are posted regularly on www.caro.ie and for the Dublin CARO on twitter @DublinCARO. Dublin CARO leads in publishing the quarterly CARO newsletter. The fifth edition will be published in late March. There are over 600 signed up to receive the newsletter. It covers a broad range of climate change issues and has an item focusing on one local authority per edition. You can sign up to the CARO newsletter at www.caro.ie/#newsletter.

Energy Management

By end 2020, DCC had improved its energy performance by 41.9%, compared to the baseline years 2006-2008, clearly surpassing its 2020 efficiency goal of 33%. In 2020, DCC consumed a total of 160 gigawatt hours (GWh) of primary energy; this is the equivalent of 28,143 tonnes of CO2 with an associated energy cost of €11.2 million. This represents an absolute reduction of 75 GWh in primary energy when compared to the baseline, (17,315t CO2). The 2020 Energy Review detailed how energy is consumed across the Council as well as setting out the councils targets for 2030. While this is a very encouraging achievement, it should not be seen as "job done" with even more challenging 2030 targets. Energy savings are not guaranteed from year to year, and effort must be maintained to improve upon these savings through ongoing monitoring and analysis. This will require continued and increased focus across all departments on the energy performance of DCC's buildings and operations over the coming decade.

The progress highlighted by the energy review is due to the efforts of each significant energy user within the council which are represented on the councils Energy Oversight Committee (EOC). The EOC was set up in 2017 by Céline Reilly, who was the Executive Manager within DCC's Environment and Transportation Department and was the Council's appointed Energy Performance Officer (EPO) (and is now replaced by Liam Bergin, Executive Manager). The EOC will continue to work to identify further potential energy efficiency and carbon saving projects, based on the findings of the Energy Review process and the actions outlined in DCC's CCAP. Targets for 2030 have now been clearly defined for Local Authorities and an evaluation of DCC's 'gap to target' is underway. This will allow for a planned response in terms of number and scale of projects, with a particular focus on thermal and transport, to achieve objectives. It will also highlight resource requirements. The DeliveREE project, a collaboration across the 4DLAs together with coordination by Codema, is looking to aggregate and scale projects of significance and to use performance contracting to help us achieve our 2030 targets. Another project nearing service phase is the upgrade of heating and lighting in the O'Brien Institute, the Fire Brigades training centre.

Building Upgrades

Dublin City Council is part of a €1.2M project led by Codema to test and develop a one-stop-shop project implementation unit for energy-efficient and renewable energy projects in Dublin, which will include over €5.5 million worth of upgrades to Dublin City Council buildings. The project was approved for support funding from the EU Horizon 2020 programme in January 2021. The 'DeliveREE' project will support the retrofit of a range of council facilities such as leisure centres, fire stations, libraries, offices and community buildings. This pilot pipeline of projects will be completed over the next four years, and is expected to reduce carbon emissions in Dublin by almost 1,700 tonnes.

A key part of the project will involve creating an innovative, standardised finance and delivery system for rolling out energy-efficiency and renewable energy projects at mass scale in Dublin. This will work by processing and assessing potential projects quickly and efficiently, in order to identify the most suitable buildings to upgrade. Once identified, these buildings of various types and sizes will be bundled together to gain large-scale impact on the efficiency of Dublin's building stock. The retrofit work will then be carried out using energy performance-based contracts, which will ensure long-term, guaranteed energy savings and will make the project more financially attractive to the client, the contractor and to private investors.

The DeliveREE was launched in late September and, in addition to Codema as lead partner, the consortium includes the four Dublin Local Authorities, alongside a range of legal, procurement and financial experts such as Resourceful Futures Ltd, Philip Lee Solicitors Ltd and Sustainable Development Capital LLC. The project will also be supported by a strategic Advisory Board made up of national government departments and authorities, financial institutes and advisors, experienced European energy agencies and European experts.

Decarbonising Zones

In response to the All of Government Climate Action Plan 2019 Action No.165 and the recent circular issued by DHLGH in February on Decarbonising Zones, the Council are in the process of identifying potential Decarbonising Zones (DZs) across the city area. The Council are being assisted by Codema and the Dublin CARO, who are providing the evidence base of local level emissions, energy use and low-carbon resources, overlaid with other location based data which will help in decision making such as locations of housing retrofit programmes, sustainable energy communities, public buildings etc. The four Dublin Local Authorities are developing a regional based approach to defining DZs.

Electrification of DCC Fleet

The Council's fleet continues to migrate to electric vehicles with 44 electric vehicles currently operating in the city. CARO are working on a national LA Fleet guidance document and Cathal Mc Coy (DCC Fleet) has agreed to sit on a working group set up by the CAROs for this project on behalf of Dublin LAs.

Air Quality Monitoring and Noise Control Unit

Ambient Air Monitoring Network

The newest local air quality monitoring station was commissioned at Mountjoy Square during March and the data can be viewed online at https://dublincityairandnoise.ie/.

An update on the Air View Project in collaboration with Google will be presented to the Climate Action, Environment & Energy SPC in April.

The new air quality station at Donnybrook Fire Station is now operating and the data can be viewed online at https://dublincityairandnoise.ie/.

Rapid Deployment Active Travel Measures

Following consultation with the Glasnevin Educate Together School and the Parents and Teachers Committee it is proposed to facilitate the setting up of a Park and Stride arrangement for the school to help alleviate congestion at the school gate. Once the Park and Stride scheme has been established it is proposed to extend the protected cycle lane along the Southside of Griffith Avenue Ext as far as Ballygall Road East. Cycle protection has been installed on Rathfarnham Road and South Circular Road.

Designs for the proposed 2 way cycle lane linking the Alfie Byrne Road and East Road were published on our consultation hub on the 24th of February. Tenders have been received and subject to their approval we would intend on awarding the contract in May with a view to starting construction in late May or early June 2022.

Designs are being developed to protect the cycle lanes on the Navan Road between Kempton Avenue and Ratoath Road.

Schools Mobility Programme

A School Zone is an initiative designed to give priority to students at the school gate by freeing up footpaths and reducing vehicle drop-offs, pick-ups and idling. The aim is to reduce congestion and increase safety at the front of school (and provide space for social distancing during the pandemic), and prioritise active travel to and from school. Dublin City Council received 119 eligible applications for a School Zone. School Zone treatments have been installed at of these 67 Schools, leaving a further 52 awaiting treatment. Schools in 30 km/h roads were initially prioritized for treatment.

The breakdown of the School Zones completed per administrative area of Dublin City are 13 for the South East Area, 16 for the South Central Area, 14 for the Central Area, 9 for the North Central Area and 15 for the North West Area. The breakdown of School Zones awaiting treatment per administrative area of Dublin City are 14 for the South East Area, 2 for the South Central Area, 13 for the Central Area, 17 for the North Central Area and 5 for North West Area.

At the start of 2022, the 67 completed School Zones were invited to complete an online survey of their experience of the School Zone. To date we have received a 19.5% response rate. The main areas of investigation are:

- Perceived changes in regards to parking on the footpath, other illegal parking, congestion and speeding pre and post School Zone Installation.
- Perceived changes for safety at the school gate since the School Zone installation.
- Perceived changes in the number of children walking, cycling or scooting to school and additional supports required to promote this.
- Experience of engaging with local residents concerning the School Zone installation and feedback from this.
- Any awareness raising or messaging carried out by the school with their school community on the SZ and to identify any damage or repairs needed. The School Mobility Officer is contacting the outstanding schools to increase response rate to this survey.

The Roads & Traffic - Road Safety Education & Training/School Warden Service are auditing the condition of the completed School Zones from the design drawings as part of their current audit on the needs for current and future School Warden crossings.

Collaboration is continuing with School Warden Service, Parking Enforcement and Green-Schools Travel Officers, local area offices and community Gardai on the development of information for schools in promoting the effective use of their SZ in terms of promoting legal, respectful and sensible parking and driving in an around schools. The School Zone brand will need to be associated strongly with the expectation on parents not to drive into the SZ area. Parents dropping off children directly at their school can be perceived as a timely, convenient and safe route to school despite the resultant traffic congestion and lack of physical space at the gates. Initial discussions with the community Gardaí and DCC parking enforcement

officers reveal that their ability to be present at all school times to be able to issue fines will not be a practical solution to continued problematic parking around schools. In the coming months the School Mobility Officer will work with the Green-Schools Travel Officers to promote alternative parking cycles buses and walking buses for current schools.

Following the results of the survey and audit of School Zones aligned to Warden services we will identify some pilot sites for a joint communication campaign with schools.

We are maintaining contact with all schools in regards to the status of their SZ and responding to all requests for updates

The Safe Routes to School (SRTS) Programme, which was launched by the Government in March 2021, aims to create safer walking and cycling routes within communities, alleviate congestion at the school gates and increase the number of students who walk or cycle to school by providing walking and cycling facilities. The SRTS programme expands it remit past the school gates and encompasses physical measures along the route to school. Precise details of the works to be undertaken in and around the individual schools will be determined after a detailed assessment has been carried out by the relevant local authority.

Twenty-seven schools in the Dublin City Council area were placed in Round 1 of the SRTS roll out. Thirteen of these have already received a School Zone. A further 23 schools were placed in subsequent rounds. Any SRTS application on a 50km/h road who also applied for a School Zone will be prioritised in the first instance.

We are supporting An Taisce Green-Schools to obtain all the required information from these Schools for the SRTS analysis, including parent surveys of where and how they make their School journey. To fast-track the implementation of both School Zones and SRTS infrastructure, we are preparing a Request to Tender document to engaging professional services for the design of these schemes.

Any school which has not applied under either the School Zone or SRTS schemes, cannot be prioritized for intervention prior to those which have. However, we are noting the requests and assisting customers to make an appropriate referral to either Traffic Advisory Group, School Warden Service, Parking Enforcement or alternative Sustainable Transport Projects that may be planned for the area.

A Tender to engage professional services for the design of additional measures to completed School Zones, awaiting School Zones and Safe Routes to School is now live.

Information on a **Park and Stride** - Alternative Parking for parents of Glasnevin Educate Together has been developed to support the extension of the protected Griffith Avenue cycle route. The school will be supported to use this after Easter.

Bicycle Heroes Project

The Bicycle Heroes Project facilitates pupils to create local solutions to barriers to cycling and become cycling advocates. Children have a unique perspective on their surroundings yet often go unheard. That's why a coalition of organisations are enabling young people to tackle urban challenges head on with a project shared between Dublin, Lisbon and Rome, that gives city building tools to children. Throughout 2022 young people will compete to create solutions to local cycling barriers, before working with city authorities to implement the best ones. Bicycle Heroes: Youth Voices for Active Mobility and is supported by EIT Urban Mobility, an initiative from the European Institute of Innovation & Technology, a body of the European Union. The

programme has been piloted by coordinating organisation BYCS over the last five years in the Netherlands. BYCS is an Amsterdam-based global NGO supporting community-led urban change through cycling. Nearly ten thousand children have taken part in the initial awareness and problem-solving phase of the program, leading to the selection of approximately 150 Bicycle Heroes. The 2022 project builds on these successes.

Dublin City Council are rolling out the Bicycle Heroes Project in Dublin in partnership with Trinity College Dublin and European Partners. Local co-ordinater is Dublin Bicycle Mayor, Donna Cooney. The Project kicked off in March 2022 with a pilot workshop for transition year students in Trinity College. Students were tasked with designing active travel solutions for the route from Heuston Station to Trinity College Dublin. Following this, Dublin City Council invited three schools to participate in the Bicycle Heroes Project. The three schools were chosen due to their participation in the Trinity Access Programme and their commitment to sustainable travel to school – as highlighted by their application under either the School Zones and/or Safe Routes to School programmes. Bicycle Heroes will complement the SZ and SRTS programmes by providing additional engagement with the pupils and will look beyond the school gate to the route to school, and also the route to Trinity College in the City Centre. Over the month of May, and specifically during Bike Week, workshops will be held with pupils where they will be facilitated to reimagine their streets to create safer active routes to school and to Trinity College. Pupils will be given the opportunity to present their visions for better routes to engineers, planners and decision makers to influence infrastructure in their own communities. An exhibition of the proposals and designs will be celebrated at venues associated with Dublin City Council and Trinity College Dublin in Autumn 2022.

Handshake Immersive Symposium

Dublin City Council is participating in an EU project called Handshake. The project involves thirteen cities collaborating on over 60 measures across 23 different types of solutions, which are designed to make cycling a more attractive everyday mode of transport. As part of this project, Dublin is being mentored by Amsterdam and the 2 cities are taking part in an immersive symposium in Dublin from the 23rd to the 25th of March. Once the agenda is finalised, invitations to relevant sessions will be issued directly to all Councillors.

The Active Travel (AcT) Programme

The Active Travel Programme Office has been set up with effect from 14th February 2022 with Andy G. Walsh as the appointed Director for the Active Travel (AcT) Programme.

Several staff have been transferred from the Traffic Division to work on delivering the cycling and walking network. Additional staff are currently also being recruited to the new Office to ensure full resourcing.

One Senior Transportation Officer and two Senior Engineers have added to the Active Travel Team and a further number of engineers will shortly be appointed following recent interviews.

The Clontarf to City Centre (C2CC) Cycle and Bus Priority Project commenced works on the 28th of March with a ceremonial sod turning by Lord Mayor of Dublin Alison Gilliland.

Interim Schemes: A constraints analysis of the Dublin City Cycle Network is underway in order to identify sections of routes where interim cycle measures can be delivered within the next 18 to 24 months.

The design of interim measures along the following routes has commenced: Prospect Way, Harolds Cross to Ballymount, Kilmainham to Thomas St and Rathmines to Milltown.

Topographical and drone surveys of these route corridors have been completed and design teams are preparing preliminary design drawings. These will be discussed initially with the representatives of the Administrative Area Offices and Elected Representatives before proceeding to further consultation which is expected to be undertaken in Q2/Q3 2022.

The Dodder Greenway (Herbert Park to Donnybrook). The Contractor appointment for the main construction contract for the remaining leg within Herbert Park will be awarded in May 2022. This project will be delivered during Q1 2023. The Contractors will be mobilising for the main works by May 2022.

The tender for the works for the Royal Canal (Phase 3) has been published.

The amending Part VIII for the Royal Canal (Phase 4) will be put back on public display during May 2022.

Additional details and information will be available for next month's edition of this report.

This Active Travel Programme office (AcTPO) will issue its first comprehensive Quarterly report at the May Full Council Meeting.

Sustainable City Centre Strategy

The Covid-19 Crisis and the changes that it has brought to the city and its likely knock on consequences on the city's transport needs and the overall mobility movements in the city require that the existing City Centre Transport Strategy document be updated. This will require DCC to both look at the pattern of mobility in the city pre Covid-19 and what is now needed for the next number of years.

In addition projects such as Metro link, Bus Connects, Dart +, Luas extension to Finglas and the increase in cycling funding allocation will require a coordinated view of how these projects will work together and what is required over the next 5-6 years. The Council is also working with the three other Dublin Authorities, SMART Dublin and the CARO to publish an overarching electric vehicle charge point deployment strategy within the context of our sustainable urban mobility strategy and the Government's vehicle electrification targets.

Environment & Transportation Department Input to the Development Plan Review

Transportation Planning Division (TPD) supports the Planning Authority in carrying out its statutory Forward Planning and Development Management functions. In 2021, the main Forward Planning focus is on the review of the 2016-2022 Dublin City Development Plan which commenced mid December 2020. The review takes up to 2 years and will conclude with the adoption of the final City Development Plan 2022-2028 towards the end of 2022.

Transportation Planning Division has direct responsibility for writing the Sustainable Movement & Transport chapter and supporting appendices, guidance documents and standards. This will be done in consultation with all of the relevant divisions across Environment & Transportation Department.

As the largest department within the Council, it was considered important to streamline the consultation process in order to ensure that information gathering and sharing is collated and managed in an effective manner. Transportation Planning Division has developed a bespoke online consultation process and associated tools to facilitate department wide input to the development plan review process. Initial internal consultation within the Department finished on 26th March. A review of input received is currently underway and will inform the Sustainable Movement & Transport chapter and supporting documentation. Further internal consultation will be undertaken as required. A collated report with responses to all input given will be circulated when complete within the department. It is envisaged that this bespoke consultation process and associated tools can be used as a mechanism for future department wide consultation and engagement.

In tandem with the internal consultation within the Department, the Transportation Planning Division is also involved in the preparation of the Chief Executive (CE) Reports on the public consultation for the Development Plan. In total, three phases of public display and wide ranging consultation will take place throughout the two year review process. The consultation for the Pre-Draft stage finished on the 22nd of February 2021 with over 750 submissions received. The Transportation Planning Division was responsible for reviewing and responding to over 190 submissions relating to Sustainable Movement and Transport on behalf of the Chief Executive. The final CE Report on the Pre-Draft Consultation Stage was issued by the City Planner to the Elected Members for their consideration on the 19th April 2021.

Transportation Planning worked closely with the Planning Department to review the motions submitted at pre-draft stage by the Elected Members. In total over 1000 motions were received. A report from the Chief Executive with responses issued to the Elected Members in June. The Planning Department finalised the Draft Development Plan ahead of issuing it to the Chief Executive for review in August 2021.

The Draft Development Plan was subsequently circulated to the Elected Members in September after which over 350 motions were received and responded to by the Chief Executive. The motions were debated at length during three Special Council meetings in early November, after which amendments were made to the Draft Plan on foot of the agreed motions.

The Draft Development Plan will now be put on formal public display for 10 weeks on Thursday 25th November 2021 until mid-February 2022. Further stages of consultation, amendments to Plan and preparation of CE Reports will be carried out in Q2 and Q3 2022, with the Transportation Planning Division continuing their role in assisting the Planning Department in the Plan making process.

The Strategic Flood Risk Assessment is being updated as part of the New Development Plan.

Reports on Planning Enforcement, Building Control, Derelict Sites, Property Management and Finance are updated on a quarterly basis.

Culture, Recreation & Economic Services

New Policy/Strategy

Dublin City Libraries **new online system**, **Spydus** is now up and running with many features to help us provide a better service to members. The system was delivered by DCL for the entire country. More information <u>here</u>.

DCL will introduce the **My Open Library** initiative at Pembroke Library during May, greatly increasing public access to the library, with unstaffed hours available from 8:00am till 10:00am and 8:00pm till 10:00pm Monday to Saturday, and from 8am till 10pm on Sundays. Regular staffed service will continue during advertised hours at Pembroke Library.

Local Economic and Community Plan 2022-2027 (LECP) Advisory Group has been formed and hosted their innagural meeting. The LECP will be developed via a six stage process and regular updates will be provided.

A comprehensive review of DCC sports and recreation infrastructure has commenced, this will inform strategic sports infrastructural planning into the future this is ongoing. In parallel with the infrastructural strategy a new Dublin City Sports Plan will be developed and aligned with the City Development Plan and incorporating a review of the Dublin City Sports and Wellbeing Partnership. The strategies when complete will be presented to the appropriate SPC's later in 2022.

Departmental Priority

The 'My Little Library Book Bag' initiative is part of the National First 5 Strategy and is available free for every child starting school in 2022. Bags can be collected at any library and will include three books to help with starting school, a story card on going to the library and a postcard the child can send to their new teacher. When they join the library, they will get a library card and wallet to use.

UNESCO City of Literature The Dublin Literary Award winner announcement will take place at the ILFD on Thursday 19 May at 1.00pm and will be followed by the Winner Interview at the festival on Saturday 21 May at 6.00pm. The UNESCO office is supporting two other keynote events at the festival: *Abuja creatives at the ILFD 2022* and the Finale event: *A celebration of the lives and work of Eavan Boland and Thomas Kinsella.*

Start Your Own Business Series The Central Library in conjunction with Dublin City LEO is running a series of free business hybrid sessions designed to empower potential entrepreneurs. Delivered by Optimum, the talks will look at the characteristics of an entrepreneur and the tools that are required to successfully start a business in any industry.

Bealtaine is Ireland's national festival that celebrates the arts and creativity as we age. DCL will host a series of interactive talks and workshops encouraging people to get creative and try something new, including Crafts, Creative Writing, Gardening, Literature, or Music.

The **Phizzfest** Community & Arts Festival will take place in Phibsboro from 13th to 15th May. Phibsboro Library will run two special events: **Sanctuary** (Saturday 15th May 2PM) A conversation with writer Gavin Kostick whose Jewish grandparents arrived in Phibsboro from Lublin, Poland; **the Walkeleles**, a high energy ukulele band will perform in the library garden and then embark on their world tour of Phibsboro, ending with a finale gig in McGeoughs. Starts Saturday 15 May at 4pm, Library garden.

History and Heritage Cabra Library will host a lunchtime series, the **Irish Revolutionary book club** facilitated by Dr James Curry, Dublin City Council Historian in Residence. (10th and 24th May at 1pm)

Raheny Library has re-opened following temporary closure for extensive refurbishment. A 50th birthday celebration is being planned for the Summer and the local community will be invited to attend.

Dublin Regional Enterprise Plan 2024 Launched on 01/04/22 by Dept of Enterprise, Trade & Employment. Dublin City Council manages approximately 24,952 tenancies, with a rental income of c. €93m projected for 2022. Average Council rent in July 2021 was €70.86 per week. The weekly rent charge is determined in accordance with the 2019 Dublin City Council Differential Rent Scheme. Tenants have a range of options to pay rent including direct debit, household budget, and cash payment in Post Offices and online or telephone payment via credit card.

The Home Grants Unit delivers three grant schemes to provide assistance to people making adaptations to their privately owned homes to meet their medical needs or to older people carrying out essential repairs. On submission of a full application, an applicant will have an initial inspection from a Dublin City Council Technical Inspector within four weeks of receipt of the application. In circumstances where an urgent hospital release or other critical cases require immediate attention, the Home Grants Unit will try to carry out an inspection immediately after contact is made and the application will be fast-tracked.

The Parks Service manages a diverse range of parks and the amenities within the parks for passive recreation, play and outdoor sports. The conservation of the built and cultural heritage of City Parks are key functions as are the management of park visitor facilities such as tearooms and toilets. Each Parks District has gardeners/horticulturists employed to care for the public gardens and civic decoration of the City.

As part of the play development programme there are 67 well equipped playgrounds providing play opportunities in almost every neighbourhood in the City. The tree care programme involves care of the City's 100,000 trees in parks and on streets through a planned work programme based on good arboriculture practice and in response to customer service requests. The landscape maintenance programme for residential open spaces involves weekly litter picking along with the maintenance of amenity and pollinator friendly wildflower grasslands. The management of the North Bull Island Nature Reserve and nature conservation through the implementation of the city Biodiversity Action Plan are important services which support corporate objectives.

A project design programme for new parks, urban spaces and the improvement of park amenities is an essential service for the maintenance of the quality standards of park

infrastructure and the provision of the social, environmental and well-being benefits for citizens and visitors to the City.
