Naming & Numbering Proposal for a new residential development on a site at Saint Columban's, The Hole in the Wall Road and the R139 Road, Donaghmede, Dublin 13 & No 25 The Hole in the Wall Road, Donaghmede, D 13 Planning Ref: SHD0017/21 Condition 7 & ABP-310944-21

Griffin Point, Clarehall Avenue, Dublin 13

This is a new residential development by Downey Planning, on a site at Saint Columban's, The Hole in the Wall Road and the R139 Road, Donaghmede, Dublin 13 & No 25 the Hole in the Wall Road, Donaghmede, Dublin 13. The development will consist of 410 apartments across 4 blocks, A-D. The development is indicated on the attached drawing **SM-2022-0396**

The name "Griffin Point" was submitted to Dublin City Council for the name of the overall development. The developer is proposing the 2 main blocks in this development to be named "Griffin Hall" and "Griffin Point". The Heritage Officer recommends approval of the overall name and the 2 main blocks. The Irish translation has been supplied by DCC's Irish Office in conjunction with Brainse Logainmneacha.

The proposal is as follows:

Griffin Point, Clarehall Avenue, Dublin 13 / Pointe Ghrífín, Ascaill Halla an Chláir, Baile Átha Cliath 13.

"This name is derived from its location beside the Balgriffin and Clongriffin areas and therefore the "Griffin" element of the name has been chosen. The "Point" section of the proposed name is derived from the fact that this will be something of a wayfinding development beside the roundabout on the Grange Road (R139) & Hole in the Wall Road."
