Environment and Transportation Department

Control of Stationless On-Street Bicycle Hire Bye-Laws

Moby have a fleet of 140 electric bikes available for public hire. Bleeper continue with their successful operations with over 800 bikes now available for public hire. Both operators have provided free bikes for healthcare workers throughout 2020/2021 and this is continuing in 2022. The ongoing roll out of additional bike parking continues which will facilitate the expansion of stationless bike operations. Stands to accommodate an extra 554 bikes were installed during 2021. Bleeper's membership increased from 76,000 at the end of 2020 to currently stand at over 110,000. Over 438,000 journeys were made on Bleeper bikes in 2021. Bleeperbike users cycled over 950,000km in 2021 saving the equivalent of 137 tonnes of carbon and were cycled for over 275,000 hours in 2021. Research is ongoing regarding integration/interoperability options with other mobility/transport services. A trial Bleeper cycling hub in Crumlin village was launched on the 3rd June. Bleeper recently launched a trial 24/7 service to facilitate demand from late night and shift workers and have also launched a new more user friendly App which allow for remote lock opening. Both operators have become members of Mobility Partnership Ireland which was launched in May and represents several private sustainable transport companies.

E-Cargobikes for Business Pilot

Dublin City Council and bike sharing operator Bleeper are progressing well on the e-cargobike for business pilot project. The project gives businesses access to e-cargobikes at a discounted rate, enabling them to replace trips which would otherwise have been taken by car or by van. The pedal-assist electric cargobikes are available to businesses at a discounted rate of €100 per month. The bikes have a cargo carrying capacity of 60kg, with a battery which can last for up to 160km and can be fully recharged in 6 hours. The project has been so successful that an extension of the project has been agreed. The timeframe has been increased to allow for a further 10 opportunities to be provided to qualifying businesses. To date over 20 e-cargobikes have been delivered to successful participants, and 34 businesses have made applications. As part of Bike Week 2022, a public webinar was held on May 16th to showcase the project to date.

Parking Tag and alternative methods of paying for parking

Due to the Covid-19 Virus isolation, the number of transactions per week in April 2020 had reduced to 10,500 from a high of 126,155 earlier in 2020. The number of weekly transactions for week ending 14th November 2021 has risen to 102,535. Since the beginning of the Covid-19 situation, the numbers using the Parking Tag had dropped very significantly in line with the reduction of parking meter usage. The weekly revenue on average of €400,000 had reduced to €25,000 for Pay and Display parking in March and April 2020. However, the numbers using the Parking Tag have increased and by week ending 07/08/2022 that week's revenue was €257,162.17.For week ending 07th August 2022, the usage of coin in parking meters was €91,065.52 and card payments were €88,330.55.

Permit Parking, Pay & Display

The following Pay and Display and Permit Parking Scheme have a change of hours that came into operation.

In addition to the existing Car Club companies GoCar and Yuko operating within the Dublin City Council administrative area, a third company Enterprise Rent A Car has been licensed to operate in Dublin City from September 2021. This brings to three the number of car club companies operating in Dublin City and the total number of live Car Club permits currently issued is 419. As of 2022, management of the Car Clubs has been transferred to the Micromobility Unit.

Climate Action Regional Office

CARO was invited to the Oireachtas Joint Committee on Environment and Climate Action on 31st May. The four regional CAROs were represented. David Dodd represented DM CARO. The submission 'Challenges and opportunities for local authorities in climate action', was given on behalf of the County and City Management Association Climate Action, Transport and Networks Committee. The meeting was productive and issues raised included

 District heating, data centre concerns, using planning for Climate Action, Active Travel, bottom up community engagement, renewable energy, resources for LAs and CAROs, Decarbonising Zones, sea level rise, public lighting and embodied carbon

CARO, the four Dublin Local Authorities and SMART Dublin are part of the EV Regional working group. CARO attended the launch of Dublin's first Electric Vehicle Strategy in DLR on 13th June. The strategy envisages 1650 charge points by 2025. The Dublin region represents 25% of Ireland's car fleet and has an important part in the decarbonisation of the country's transport system. The four DLAs are currently identifying priority areas that require the installation of residential charging solutions supported the four LAs. The DLAs are engaging with the public to help identify areas where there is local need.

Dublin CARO, the Local Authority Services National Training Group (LASNTG), Greenville Procurement Partners and a number of strategic partners have developed Green Procurement Training for local authorities. This training is a key action for delivery of the LA Climate Action Charter 2019 whereby local authorities have pledged to implement green public procurement strategy and procedures across all business areas.

Strand 1 of this training is a 45-minute introduction to green public procurement webinar aimed at local authority staff across all departments and levels. This strand went live in May. Strand 2, a 3 day course comprising self-directed and on-line training commenced on 13th June. It is aimed at procurement officers, budget holders and decision makers.

Strand 3 will be available in September. It is aimed at staff involved in developing the green procurement strategy in local authorities.

Invitations to staff to complete this training will be via the training officers in the LAs and will be offered for up to 1 year.

CARO is continuing the roll out of the Local Authority Climate Action Training programme for local authority staff. The training programme was developed by CARO in conjunction with the LASNTG and other expert partners such as Climate Ireland. Further information is available on the CARO website https://www.caro.ie/training-events/training

The Actioning Policy pillar for training specialist groups will continue across 2022 and 2023. CARO, in collaboration with Age Friendly Ireland (AFI) are progressing plans for a series of Climate Action workshops during 2022. The training model is a hybrid of in person and virtual workshops. The procurement process is ongoing. Quotations were requested from three companies. The Education for Sustainable Development (ESD) Company's submission was successful. AFI, CARO and ESD are progressing the plans for the 2022 Climate Action Workshops. One of which will take place during Dublin Climate Action Week, 12-18 Sept. 2022.

Línte na Farraige is one of the 15 successful Creative Ireland Climate Action fund projects, Dublin CARO collaborated with Local Authorities, artists and 3rd level institutes and other partners on this project. Two CARO staff are part of the project team. The potential sites have been selected in Fingal CC, Wexford CC, Galway CC and DLRCC. The sites are subject to approval by the local authorities and ministerial consent as they are national heritage and archaeological monuments, and subject to adequate funding. The illumination may be in place for up to six months. The proposed Línte installations will use illuminated LED horizontal lines to represent future sea-level and storm surges. An interactive website and community engagement activities will be part of the installation. Trialling the use of climate games in local schools to promote climate action and awareness is proposed as part of the Línte project. The project is progressing. A Línte promotional video is being developed and the installations are planned to be in place Q3 2022. The project launch is planned for late August. The Línte communications strategy plans are progressing.

CARO are represented on a national technical advisory group to assist LAs in preparing new national guidance to prepare 'Climate Action Plans 'as per the requirement in the Low Carbon and Climate Action (Amendment) Act 2021. This Draft Guidance was with DECC for agreement and wider circulation to the LA sector. The templates for completion of the CCAP progress report have now been sent to the four DLAs. They are similar to previous years. The deadline for submission to DM CARO is 7th Sept.

Dublin CARO prepared a response on behalf of the four CAROs nationally as a key stakeholder on the revised National Adaptation Framework (NAF). A full public consultation on the NAF is planned. The CARO will encourage LA Climate Team to make appropriate submissions.

CARO is collaborating on a Green Roof project with UCD. The purpose of the project is to investigate how effective green roofs are in decreasing storm water runoff from developments and the extent of flooding. Progress on this project has been delayed by COVID. It is proposed that baseline data will be collated on public and private sector roofs over a period of one year with data being used to calculate water attenuation from a flood prevention perspective. The project was announced on World Green Roof Day 6th June.

Dublin CARO is supporting the Smart Dublin Smart Cities Climate Action Data Challenge competition to use open data to promote and support climate action. The challenge was launched 30th March 2022 and the closing date for applications was extended to 10th May. The short listed applicants have been appointed mentors to advise them in progressing their projects. Project Completion is planned for late Q3. David Dodd, CARO Coordinator is mentoring one group I Adapt in Trinity College which is using an online game 'Climate Smart' in schools to help communicate climate change impacts and the need for climate adaptation.

DM CARO attended and assisted at the recent Climate Key Performance Indicators (KPI) Climate Action Workshop in Athlone in July. All the local authorities sent employees to represent them. Potential new KPIs were considered. The workshop was organised by the CAROs. The CARO is working closely with the DLAs and other CAROs ion progressing plans for the Climate Action Plan preparation including the preparation of the 3rd Climate Change Action Plan (CCAP) annual progress report to be submitted to DECC in October 2022. CARO and Codema will continue to assist LAs in implementing these CCAPs.

The Dublin CARO is progressing a number of event alongside the DLAs and Codema for the 2nd Dublin Climate Action week DCAW22 from September 12th to 17th. More info at www.dublincliametactionweek.ie. Further updates from the CARO team and events are posted regularly on www.caro.ie and for the Dublin CARO on twitter @DublinCARO. Dublin CARO leads in publishing the quarterly CARO newsletter. The sixth edition was published in

late March and the next edition will be end of June. There are over 600 signed up to receive the newsletter. You can sign up to the CARO newsletter at www.caro.ie/#newsletter.

Electric Vehicle Charge Points

The strategy is now complete The Dublin Local Authority Electric Vehicle Charging Strategy is now complete. The executive Summary and the full report will be available for download through the Council website in the next couple of weeks. This research piece will enable each Local Authority in the Dublin Metropolitan Area to develop related but distinct implementation plans, based on local needs and related policies. Where commonality of approach allows, the DMA working group will collaborate to improve efficiency (for example in the area of procurement).

The DCC implementation plan will include the identification of Council and community facilities that may allow scope for facilitating the siting of EV charge points.

In due course, DCC understands that the Department of Transport's recently launched ZEVI office, which sets out potential new sources of funding and capacity building measures to enable the transition, will allow DCC to facilitate the installation of chargers.

Furthermore, variations to the City Development Plan 2016-2022 introduced new objectives such that all new parking for new (or extensions to) housing, apartments and places of employment that provide car parking shall be electric charge point enabled.

Dublin City Council will work closely with the ESB and other stakeholders to enable and facilitate an increase in the number of EV charge points across the city. All new (or upgraded) commercially operated car parking developments will be required to provide a minimum of 50% of spaces with EV charging facilities.

Additionally, Dublin City Council has also been in close dialogue with the SEAI/ZEVI (the recently launched Zero Emission Vehicles Ireland Office) regarding the available schemes of funding and a proposed new scheme of grant aid for Multiple Dwelling Units designed to facilitate EV charging infrastructure.

The preparation of the new City Development Plan 2022-2028 will provide an opportunity to review the implementation of the revised objectives from the previous plan and also incorporate the relevant outcomes of the above mentioned study, to deliver an EV charging solution for the Dublin Metropolitan Area

A pilot off-street small-scale public charging mobility hub in Finglas is now practically complete and will launch in early September. Data from usage will help inform future plans. The project:

- Begins to breathe life into our strategy/policy of mitigating risk to DCC whilst enabling and facilitating in this space and modelling the recommended approach for EV charging as per strategy and crucially within the context of our wider mobility strategies and policies
- Will have two chargers; AC (nominally 22KW), 2 charging spaces and DC 75KW, 2 charging spaces
- Dedicated Car Share Club EV charging space (one of the AC spaces), to be rotated between all 3 licenced operators in Dublin City across the pilot duration
- ➤ A dedicated eBike commuter hub with 8 eBikes under the brand HubX (an offshoot of ESB), in association with Beeper Bikes

In addition, a mapping tool is now available on our web site to allow the public suggest where they think there is a requirement for charging. Whilst this will not guarantee a charge point at that location it will allow the Council build a picture of demand and will help inform the process of rolling out the strategy. In addition, there will also be a dedicated charging facility for a DCC staff EV for use on Finglas Area Office business.

Energy Management

DCC's energy consumption can be broadly split between Electricity (55%), Thermal/Gas (32%) and Transport (12%). DCC has two key targets for 2030:

- i) An improvement in energy efficiency of 50% from a 2006-2008 baseline, and
- ii) An absolute reduction in tCO2e (tonnes of Carbon Dioxide equivalents) of 51% from a 2016-2018 average.

Modelling work is continuing to translate these targets into quantifiable reductions required and to begin developing project pipelines to achieve same. A significant ramp up in terms of the number and scale of projects will be required to meet these tough targets. Ongoing.

In 2021, DCC consumed a total of 166 gigawatt hours (GWh) of primary energy; this level of consumption produced 31,200 tonnes of CO2e emissions, with an associated energy cost of €12.4 million. Energy prices are rising rapidly, in addition to and independently of, the carbon tax (currently at €41 per tonne and rising to €100 per tonne by 2030). DCC, through its OGP sourced contracts has been somewhat sheltered from these global shifts in price, although very significant retail price increases (in the order of 160 – 260%) will result in a significant cost increase to DCC from H2 2022.

A forecasting tool has been developed which will help quantify anticipated levels of cost increase based on differing inflation rates and this should help with budgeting for each significant energy user (SEU) across the Council.

The Energy Review details how energy is consumed across the Council as well as setting out the councils targets for 2030. Whilst very good progress has been achieved to date, it should not be seen as "job done" with even more challenging 2030 targets. Energy savings are not guaranteed from year to year, and effort must be maintained to improve upon these savings through ongoing monitoring and analysis. This will require continued and increased focus across all departments on the energy performance of DCC's buildings and operations over the coming decade.

The progress highlighted by the energy review is due to the efforts of each significant energy user within the council which are represented on the councils Energy Oversight Committee (EOC). The EOC will continue to work to identify further potential energy efficiency and carbon saving projects, based on the findings of the Energy Review process and the actions outlined in DCC's CCAP. As above, targets for 2030 have now been clearly defined for Local Authorities and an evaluation of DCC's 'gap to target' is underway. This will allow for a planned response in terms of number and scale of projects, with a particular focus on thermal and transport, to achieve objectives. It will also highlight resource requirements. The DeliveREE project, a collaboration across the 4DLAs together with coordination by Codema, is looking to aggregate and scale projects of significance and to use performance contracting to help us achieve our 2030 targets.

Building Upgrades

Dublin City Council is part of a €1.2M project led by Codema to test and develop a one-stop-shop project implementation unit for energy-efficient and renewable energy projects in Dublin, which will include multi-million upgrades to Dublin City Council buildings. The project was approved for support funding from the EU Horizon 2020 programme in January 2021. The 'DeliveREE' project will support the retrofit of a range of council facilities such as leisure centres, fire stations, libraries, offices and community buildings. This pilot pipeline of projects is currently being developed and is expected to reduce carbon emissions in Dublin by almost 1,700 tonnes.

A key part of the project will involve creating an innovative, standardised finance and delivery system for rolling out energy-efficiency and renewable energy projects at mass scale in Dublin. This will work by processing and assessing potential projects quickly and efficiently, in order to identify the most suitable buildings to upgrade. Once identified, these buildings of various types and sizes will be bundled together to gain large-scale impact on the efficiency of Dublin's building stock. The retrofit work will then be carried out using energy performance-based contracts, which will ensure long-term, guaranteed energy savings and will make the project more financially attractive to the client, the contractor and to private investors.

The DeliveREE programme continues to ramp up and organise to begin developing a project pipeline. The project was launched in late September 2021 and, in addition to Codema as lead partner, the consortium includes the four Dublin Local Authorities, alongside a range of legal, procurement and financial experts such as Resourceful Futures Ltd, Philip Lee Solicitors Ltd and Sustainable Development Capital LLC. The project will also be supported by a strategic Advisory Board made up of national government departments and authorities, financial institutes and advisors, experienced European energy agencies and European experts. Ongoing.

Decarbonising Zones

In response to the All of Government Climate Action Plan 2019 Action No.165 and the recent circular issued by DHLGH in February on Decarbonising Zones, the Council are in the process of identifying potential Decarbonising Zones (DZs) across the city area. The Council are being assisted by Codema and the Dublin CARO, who are providing the evidence base of local level emissions, energy use and low-carbon resources, overlaid with other location based data which will help in decision making such as locations of housing retrofit programmes, sustainable energy communities, public buildings etc. The four Dublin Local Authorities are developing a regional based approach to defining DZs.

Ambient Air Monitoring Network

The newest local air quality monitoring station was commissioned at Kylemore Park during June and the data can be viewed online at https://dublincityairandnoise.ie. An introduction for the Air View Project in collaboration with Google is being written. The project will go live to the public after completion.

Electrification of DCC Fleet

The Council's fleet continues to migrate to electric vehicles with 44 electric vehicles currently operating in the city. Further work is ongoing in respect of charger requirements for fleet across operational bases in preparation for a significant transition of fleet to EVs in 2023/24.

Sustainable Energy Communities

The SEAI's Sustainable Energy Communities scheme helps organised communities fund and prepare an Energy Master Plan to change the way communities think about energy and to help them achieve energy goals by working together. DCC, acting as lead authority, has procured a framework of specialist consultants, who will work with communities across seven Local Authorities to help them develop Energy Master Plans. Communities had been struggling with cash flow in respect of payment of consultant fees. DCC listened to these concerns and working with the SEAI have developed an MOU so that so DCC can pay the fees and reclaim from SEAI at a later date. There is close coordination with CoDEMA and best practice standards, controls and master plan templates are in place to help guide communities deliver on targets. A mentor works directly with the communities, facilitating and guiding as required. A number of SECs are now in the process of developing their Energy Master Plans under this scheme. Meetings have been held with some SECs to explore possibilities for closer collaboration in piloting innovative schemes and this is progressing, with input from Department of Transport with a view to informing national policy.

Claims Liaison Section

The Claims Liaison Section's primary objective is to assist Irish Public Bodies Insurance to effectively manage the investigation and defence of public liability and employee liability claims against Dublin City Council. The Section deals with claims spreading across Drainage, Roads Maintenance Division, Waste Management, Wastewater Services, Water Services, Public Lighting and Traffic Management. All employee claims from all departments against the Council are also investigated within the Section.

DCC is obliged under its contract for insurance with IPB to adhere to agreed protocols in liaising with IPB and their legal representatives. It is also in the public interest that the successful management and the best defence of claims against DCC is presented. The unit is also tasked with devising and overseeing risk strategy within the relevant sections to assist with a comprehensive programme of hazard identification and elimination. Assisting those Departments to identify the risk patterns and to devise controls and assist in putting such controls in place, supporting a proactive risk management strategy. The unit also liaises with IPB's Special Investigations Unit regarding possible fraudulent claims against DCC. Investigation and determination of cases continues throughout the Covid Restrictions and in 2021 the Section dealt with 537 new public liability cases 51 new employers liability claims.

Road Maintenance Services

Road Maintenance Services resolved approximately 4,200 customer enquiries and service requests during the period January to July 2022. Additionally, during the same period almost 3,500 defects and hazards on the road network were repaired and/or made safe by our direct labour crews. Furthermore, a total of 220 critical defects and hazards were repaired and/or made safe within 24 hours of being recorded. Road Maintenance Services has prepared its Annual Works Programme for 2022. The programme provides for the investment of €12 Million to upgrade 10km of road carriageways and 12.5km of footpaths. These works are currently progressing on site.

Bridges & Other Road Structures

Bridge Maintenance will commence preparation of tender documents for Principal Inspections in 2023.

Dublin Waste to Energy Community Gain Fund

With reference to the Dublin Waste to Energy community gain projects grant scheme 2021, two of the 27 approved applicants have drawn down their grant funding. The remaining 25 have until April 2023 to complete their grant aided projects. With regard to the 2022 scheme, the Dublin Waste to Energy community gain fund committee are currently in discussions and are expected to announce their decision by the end of the Summer.

The Dublin Waste to Energy Community Gain Fund Committee are scheduled to hold their fourth meeting of the year in June 2022. It is anticipated that the members will discuss the current status of the 27 approved grant applicants in respect of the Dublin Waste to Energy Community Gain Projects Grant Scheme 2021 and determine when the 2022 Scheme will be launched.

Waste Services Update

Street Grading

167 surveys were undertaken on 161 streets across the six waste management areas in July 2022. Grading was mainly carried out between 9am and 1pm Monday to Friday. 75% of streets graded received a Grade A, 12% Grade B, 11% Grade C, 2% Grade D.

Should any streets be awarded a grade C or D, a CRM request will be issued to the relevant area supervisor to address the issue that resulted in the poor grade.

Recycling Services

Waste Management Services continues to work with Dublin based artist collective, Creative Connections and the relevant Area Offices to animate bottle banks in highly visible and/or problematic locations. Animation of bottle banks at Bulfin Road, the final location for this project in 2022, has recently been completed. Work is also ongoing on repainting Waste Management Services stock of bottle banks in storage when weather permits with a view to replacing unsightly bottle banks in public spaces over the coming months. Bottle banks at Priorswood Shopping Centre, Naomh Fionnbarra GAA club and Ballyboggan Road have recently been replaced. Locations in the south city will be identified for replacement in the next phase of this program.

Compost Education

Waste Management Services recently collaborated with the North Central Area Office and Parks, Biodiversity & Landscape Services to deliver composting education to members of ten community gardens, groups and allotments within the North Central area. The course was held in the Red Stables of St. Anne's Park.

School Programmes

Picker Pals is an anti-litter initiative for primary schools. The educational programme gives young people the tools and positive motivation to develop stewardship of their local environments. Picker Pals engages children through a colourful character-led world of activity books, environmental readers, songs and storytelling. Registration is now open for the next academic year at www.pickerpalsworld.org.

Composting for Schools is a collaborative pilot project for Dublin created by Composting Ireland, the four Dublin local authorities and Eastern-Midland Regional Waste Office. The programme delivers a complete compost solution by reviewing waste segregation, providing education on managing food/garden waste and providing the composting infrastructure. 39 schools from the DCC area are participating in this two year pilot project. Participating schools also have a dedicated composting for schools webpage where they can access a library of informative resources, ask questions, upload results and interact with other participating schools. Wormery bins were recently added to the programme to provide an interactive and engaging way to managing food waste on site. 24 wooden wormery bins were constructed and delivered to interested Dublin City schools. Installation of the wormery bins will be completed in Autumn 2022 and training will be provided to participating schools.

The Relove Fashion Competition 2022-23 will formally launch in September. Secondary school students will be invited to take a deeper look at how their clothing is made and use creative reuse options such as upcycling, repairs, alterations and mending. Information packs have been sent to secondary schools and registration is now open for entries. The deadline for registrations will be 30 September 2022. Each school that registers will be entered in to a draw to win a sewing machine. The grand final of the competition is expected to take place in March 2023 at the Rediscovery Centre. Green-Schools is Ireland's leading environmental management and award programme. The student-led programme promotes long-term, whole-school action. Green-Schools continues to be delivered to primary and secondary schools by Waste Management Services staff and An Taisce. Schools will be invited to attend a Green-Schools Information Seminar in the Autumn 2022. For further information, please contact greenschools@dublincity.ie

<u>Circular Economy Training for Business - MODOS</u>

The Eastern-Midlands Regional Waste Management Plan Office, in collaboration with the Local Enterprise Offices in Dublin City Council Dún Laoghaire-Rathdown County Council, successfully ran a MODOS Circular Economy Training Programme for microenterprises and Small to Medium Enterprises during March and April 2022. The initiative was funded by the Environmental Protection Agency (EPA) under the Local Authority (Waste) Prevention Network or LAPN programme. Prior to 2022 the LAPN programme was confined to Environmental Sections of Local Authorities, but this year it was opened to all LA sections to reflect the spirit of the government's Whole of Government Circular Economy Strategy. In all, 40 participants took part in the MODOS Circular Economy Training Programme – 32

participants were SMEs operating in the Dublin City and Dún Laoghiare-Rathdown areas and the remaining 8 participants were local authority staff (EAOs and LEO staff). The participants completed 4 modules of training and took part in one online networking event. Participants also availed of a one hour mentoring session following the conclusion of the programme. A report was submitted to the EPA as part of the funding requirements. A live MODOS networking and panel discussion event was held on June 2nd at Richmond Barracks for all past participants of the MODOS Circular Economy Training Programmes and for other interested organisations in a position to promote MODOS in the future.

Circle City Recycling Initiative

The Circle City recycling on the go initiative was launched on the 19th October 2020 with 25 recycling bins installed in the Grafton Street and Henry Street areas to facilitate recycling of plastic bottles and cans 'on the go' in the city centre. Waste audits of the installed bins are being carried out to assess the success of the initiative to date and the project is ongoing. Phase 2 of the project launched in November 2021 more than doubling units of recycling on the go bins and widening locations to neighbouring streets. An increased public awareness campaign will take place throughout March and April. Project review and report will be available from Hubbub in Q2 2022.

Housing Waste Recycling Project

Assessments of existing bins and bin areas in housing and older person's complexes in North Central Area - Kilbarrack and North West Area - Finglas have taken place. A number of complexes in each area are ready for the introduction of brown bins (food waste), and where necessary green bins (recyclables). A report has been sent to Housing Maintenance for each complex and bins will be introduced in due course. Several complexes in each area require the construction of secure bin storage areas and the introduction of segregated bins will follow once these units have been constructed. Assessments will continue in Central Area, and the remainder of North Central and North West Areas over the summer months.

Bulky Household Waste Collection Service

Dublin City Councils online bulky waste ordering system is now fully digital and customers can now request and pay for a service collection 24/7 as the entire process is fully automated through the Citizen Hub Platform. Customers can now complete the ordering process from beginning to end including making secure payment without the need to go through our customer services department.

There is no material change to the actual service itself, how it operates or cost. It has simply been improved and enhanced by allowing customers to access the service at any time of the day or night. https://citizenhub.dublincity.ie Customers can also access the form through our website Bulky Household Waste Collection Services | Dublin City Council

Our customer services centre will remain available between the hours of 9am and 5pm Monday to Friday to assist customers who want information about the service or who wish to place an order.

Dublin City Neighbourhoods Awards 2022 /IPB Pride of Place Competition

The City Neighbourhoods Awards 2022 will take place on the 6th October 2022 in Croke Park. Arrangements are in place for an area wide competition. Applications are received in the Litter Management Office and closing date was Friday 27th May.

IPB Pride of Place – Finglas Tidy Towns received overall winner in their category – Urban Neighbourhood/Village under 3,000 and Bloomin' Crumlin/Kimmage received runner-up prize in their category Urban Neighbourhood/Village over 3,000 in Killarney on Monday 16th May 2022

IPB Pride of Place – Arrangements are in place to nominate new groups for 2022.

Team Dublin Clean-up

The Team Dublin Clean-up took place on 30th April to coincide with the National Spring Clean month. Almost 70 groups from Dublin city came together to clean-up Dublin. Equipment was supplied to the groups by Waste Management Services who also collected and disposed of the bags after the clean-up.

Special Speed Limit Bye-Laws 2020

In regards to Phase 4 of the Special Speed Limit Bye-Laws 2020, DCC has completed the implementing of the 30km/h speed limit signage in residential areas as per the approved Phase 4 - Speed Limit Bye-Laws 2020.

Protection of Water Bodies Office (PWBO)

DCC is working to deliver a number of projects to ensure that the opportunities to meet DCC's Water Framework Directive (WFD) obligation of achieving "good" status for all our water bodies by 2027 are maximised. Current examples are:

- The Santry River Restoration and Greenway Project is a cross-agency, multi-disciplinary project to produce a Masterplan, based on an options assessment, for the River Santry catchment in order to achieve the objectives set out in the Water Framework Directive, Floods Directive, Birds & Habitats Directive as well as the Greater Dublin Area Cycle Network. This project aims to set out the most effective plan to restore the river to a more natural state, encompassing a much-enhanced public amenity, promoting biodiversity, remediating sources of pollution and addressing potential flooding within the catchment. This project is being developed in collaboration with Fingal County Council, DCC Parks, Landscape Services & Biodiversity, as well as DCC's Active Travel unit of the Environment & Transportation Department. LAWPRO, the EPA and Inland Fisheries Ireland are supportive of this scheme. Funding is mainly from the Urban Regeneration and Development Fund, and, in the case of the greenway, the National Transport Authority.
- The Protection of Water Bodies Office is progressing a pilot surface water management project using Green Infrastructure principles. This project scope has been refined to prioritise and enhance five of the original nine locations identified adjacent to the Dodder and Santry river catchments. These Sustainable Drainage Systems (SuDS) are expected to have the dual effect of reducing the rate of surface water runoff into sewers/watercourses, thus reducing the risk of downstream and local flooding. Equally important is the expected outcome of improving the water quality and enhancing biodiversity opportunities in the public realm.
- Culvert Improvement Works Screen Upgrade Works. The Contractor has been appointed for the works. This work will provide safer access for staff to maintain 22 screens which collect debris from watercourses and provide public safety, particularly during times of heavy rainfall.

Bathing Waters

The Bathing Waters Task Force (BWTF) has the primary objective is to protect public health, and to achieve the objectives of the EU Water Framework Directive for Dublin Bay. DCC continues to support and collaborate with taskforce stakeholders to ensure a coordinated approach to identify, remediate and remove bathing water pressures is being achieved.

The official bathing season commenced on June 1st and will run until 15th September. DCC monitoring of bathing water continues and the water quality assessment results are available at https://www.dublincity.ie/residential/environment/protection-water-bodies/beaches-and-bathing-water-quality and on the National Bathing Water website www.beaches.ie.and-cabinets-adjacent-to-identified-bathing-areas.

Our Water Pollution Control section undertook a Public Participation campaign for the identification of new bathing waters between 9th May and 9thJune 2022. One submission was received for eth boat slipway at Clontarf to be considered as a designated bathing area. This location will be duly considered in accordance with the requirements Bathing Water Regulations 2008.

A six-month trial of 'smart signage' was recently installed at Sandymount & Dollymount Strand. This project will monitor and assess the potential to deliver regulatory messaging to the public in a more efficient, sustainable and cost effective manner over the duration of the trial. It will be a temporary installation and does not require connectivity to external utility services.

Drainage Planning

In addition to providing drainage input on planning applications, including SHDs, we are advising on LAPs, SDZs and the City's New Development Plan. We are providing drainage input on major new infrastructure projects such as Metro, Bus Connects and various cycle schemes. We are assisting Irish Water with new planning applications/connection applications. The SuDS Working Group is well established with multi-disciplinary representation from Drainage, WFD, Roads, Climate Change, Parks, City Architects and Planning.

The Working Group agreed 3 new appendices to the new Development Plan which support policies in that plan. These cover:

- Surface Water Management Plans.
- SuDS guidance
- Green Blue Roofs policy.

Three new guidance documents have been introduced:

- SuDS Design and Evaluation Guide
- Green Blue Roofs Guide
- SuDS Retrofit Guide

The new Guidance documents were presented to the Climate Action, Environment & Energy SPC on the 25th May.

Flood Defence Camac River

 Consultants have been appointed by DCC to investigate the reduction of flood risk across the DCC and SDCC sections of the River Camac. Environmental and topographical surveys are now complete. A computer model has been built to investigate tidal, fluvial and pluvial flood risks associated with the river. Preliminary flood extent maps have been verified. Sensitivity testing and site investigation procurement is underway. Flood alleviation options such as storage and de-culverting are currently being computer modelled. A further public consultation is planned in September following the successful ones in June.

- This study as with all other flood alleviation projects is being integrated into a desire to "de-culvert" and widen what is now seen as an over engineered river where possible so that it can, over time, be restored to a more natural state, as far as reasonably possible. The project will also involve identifying and remedying urban pollution sources, where possible. This is also being done in conjunction with an existing Greenway proposal and in tandem with Urban Regeneration and Development Fund (URDF) funded projects in the area. The new City Edge project gives opportunities to achieve some of this. River corridors of 10m-25m are sought in the new development plan where possible on this very constrained river.
- Updates on this project can be seen on Camac Flood Alleviation Project website.

Climate Action Team

The Climate Action Team submitted an Expression of Interest for the EU Mission 100 Climate Neutral and Smart Cities on January 31st. Dublin City and Cork City were announced as the two successful Irish cities that are part of the 100 Climate Neutral and Smart Cities Mission on April 28th, 2022. The first phase of the Mission will involve developing a Climate City Contract (CCC) that is not legally binding. The CCC will require the development of an action plan for reaching climate neutrality and an investment plan. The CCC is essential to receiving the Mission Label.

The Climate Action Team attended the Let's Go! Net Zero Cities Launch in Brussels on June 13th. The organisers provided opportunities for city representatives to engage with each other and the Net Zero Cities team to understand the challenges facing cities and to identify opportunities. Also announced during the event was that there will be a call for Pilot Cities. The Climate Action Team will explore this further.

The Climate Action Team is currently exploring the potential of participating in EU funding calls led by academia. Consideration is being given to projects that will further climate action.

The Climate Action Team with EMRWMPO was involved in a bid for Dublin to be the 2023 Circular Hotspot. The application was led by the Rediscovery Centre and was successful.

The Climate Action Team's Creative Ireland funded project "Eat the Streets!" that was focused on food and climate change, was successfully completed. Next steps for the project are being considered in terms of a future annual event and potential for a food strategy. The Climate Action Team invited the public to complete the Edible Dublin: Food Strategy survey. Work is on going on the food strategy and in-put is being sought from experts

DCC's Application to the Public Sector Innovation Fund – Climate Resilient Housing has been funded. In partnership with City Architects, the project will be investigating how we use digital twins to inform retrofit decisions.

DCC's application for the Creative Climate Action Fund was successful and we will be working with the Arts Office to implement this project which will engage residents of Crumlin.

DCC's application to participate in IURC was successful and we are partnered with Seoul, South Korea. This is an 18 to 24 month programme that will involve study exchanges with key stakeholders in the city of Seoul on the topics of climate change and COVID recovery. There

have been four bilateral meetings with DCC staff and Seoul staff discussing active travel. Plans are underway for study visits to progress pilot actions that will be implement in Dublin and Seoul. A study visits will take place in early September to Seoul and late November to Dublin.

The Climate Action Team is involved in a stakeholder group feeding into the development Local Authority Climate Action Plan Guidelines by the EPA and MAREI.

The Climate Action Team is developing a plan for engaging communities on local climate action that will involve the area offices. It is envisaged that there will be workshops where councillors will be invited to attend to ensure meaningful engagement and collaboration with residents.

Planning is underway for Dublin Climate Action Week 2022 in partnership with FCC, DLR, SDCC, CARO and Codema. It is set to be the week of September 12th. An important event planned for the week is on September 15th – the launch of the Climate Campaigners App. The app will present residents of the city with lifestyle challenges that they may undertake to contribute to climate action. We are in the process of developing a programme of events for the day, it is anticipated that the events will include river walks and a cycle. We encourage as a demonstration of support for councillors and city staff to download the app and share the via social media the challenges they are undertaking to reduce their emissions. The final event of Climate Action week will be the Eat the Streets Festival on September 17th. It will be held at Collins Barracks and will feature demonstrations, workshops, conversations, and local food vendors.

Schools Mobility Programme

A **School Zone** (SZ) is an initiative designed to give priority to students at the school gate by freeing up footpaths and reducing vehicle drop-offs, pick-ups and idling. The aim is to reduce congestion and increase safety at the front of school (and provide space for social distancing during the pandemic), and prioritise active travel to and from school. Dublin City Council received 119 eligible applications for a SZ. School Zone treatments have been installed at of these 67 Schools, leaving a further 52 awaiting treatment. Schools in 30 km/h roads were initially prioritized for treatment.

At the start of 2022, the 67 completed School Zones were invited to complete an online survey of their experience of the School Zone. To date we have received a 19.5% response rate. The main areas of investigation are:

- Perceived changes in regards to parking on the footpath, other illegal parking, congestion and speeding pre and post School Zone Installation.
- Perceived changes for safety at the school gate since the School Zone installation.
- Perceived changes in the number of children walking, cycling or scooting to school and additional supports required to promote this.
- Experience of engaging with local residents concerning the School Zone installation and feedback from this.
- Any awareness raising or messaging carried out by the school with their school community on the SZ and to identify any damage or repairs needed. The School Mobility Officer is contacting the outstanding schools by phone to increase response rate to this survey.

The Roads & Traffic - Road Safety Education & Training/School Warden Service are auditing the condition of the completed School Zones from the design drawings as part of their current audit on the needs for current and future School Warden crossings.

Collaboration is continuing with School Warden Service, Parking Enforcement and Green-Schools Travel Officers, local area offices and community Gardaí on the development of information for schools in promoting the effective use of their SZ in terms of promoting legal, respectful and sensible parking and driving in an around schools. The School Zone brand will need to be associated strongly with the expectation on parents not to drive into the SZ area. Parents dropping off children directly at their school can be perceived as a timely, convenient and safe route to school despite the resultant traffic congestion and lack of physical space at the gates. Initial discussions with the community Gardaí and DCC parking enforcement officers reveal that their ability to be present at all school times to be able to issue fines will not be a practical solution to continued problematic parking around schools. In the coming months the School Mobility Officer will work with the Green-Schools Travel Officers to promote alternative parking cycles buses and walking buses for current schools.

Following the results of the survey and audit of School Zones aligned to Warden Services we will identify some pilot sites for a joint communication campaign with schools.

We are maintaining contact with all schools in regards to the status of their SZ and responding to all requests for updates

The **Safe Routes to School** (SRTS) Programme, which was launched by the Government in March 2021, aims to create safer walking and cycling routes within communities, alleviate congestion at the school gates and increase the number of students who walk or cycle to school by providing walking and cycling facilities. The SRTS programme expands it remit past the school gates and encompasses physical measures along the route to school. Precise details of the works to be undertaken in and around the individual schools will be determined after a detailed assessment has been carried out by the relevant local authority.

Twenty-seven schools in the Dublin City Council area were placed in Round 1 of the SRTS roll out. Thirteen of these have already received a School Zone. A further 23 schools were placed in subsequent rounds. Any SRTS application on a 50km/h road who also applied for a School Zone will be prioritised in the first instance.

We are supporting An Taisce Green-Schools to obtain all the required information from these Schools for the SRTS analysis, including parent surveys of where and how they make their School journey. To fast-track the implementation of both School Zones and SRTS infrastructure, we are preparing a Request to Tender document to engaging professional services for the design of these schemes.

Any school who has not applied under either the School Zone or SRTS schemes, cannot be prioritized for intervention prior to those who have. However, we are noting the requests and assisting customers to make an appropriate referral to either Traffic Advisory Group, School Warden Service, Parking Enforcement or alternative Sustainable Transport Projects that may be planned for the area.

A Tender to engage professional services for the design of additional measures to completed School Zones, awaiting School Zones and Safe Routes to School is now live. We are continuing to develop resources to schools to set up **Park and Stride** initiatives.

Bicycle Heroes Project

The Bicycle Heroes Project facilitates pupils to create local solutions to barriers to cycling and become cycling advocates. Children have a unique perspective on their surroundings yet often go unheard. That's why a coalition of organisations are enabling young people to tackle urban challenges head on with a project shared between Dublin, Lisbon and Rome, that gives city building tools to children. Throughout 2022 young people will compete to create solutions to

local cycling barriers, before working with city authorities to progress the best ones. Bicycle Heroes: Youth Voices for Active Mobility and is supported by EIT Urban Mobility, an initiative from the European Institute of Innovation & Technology, a body of the European Union. The programme has been piloted by coordinating organisation BYCS over the last five years in the Netherlands. BYCS is an Amsterdam-based global NGO supporting community-led urban change through cycling. Nearly ten thousand children have taken part in the initial awareness and problem-solving phase of the program, leading to the selection of approximately 150 Bicycle Heroes. The 2022 project builds on these successes.

Dublin City Council are rolling out the Bicycle Heroes Project in Dublin in partnership with Trinity College Dublin and European Partners. Local co-ordinater is Dublin Bicycle Mayor, Donna Cooney. The Project kicked off in March 2022 with a pilot workshop for transition year students in Trinity College. Students were tasked with designing active travel solutions for the route from Heuston Station to Trinity College Dublin. Following this, Dublin City Council invited three schools to participate in the Bicycle Heroes Project. The three schools were chosen due to their participation in the Trinity Access Programme and their commitment to sustainable travel to school – as highlighted by their application under either the School Zones and/or Safe Routes to School programmes. Bicycle Heroes complements the SZ and SRTS programmes by providing additional engagement with the pupils and will look beyond the school gate to the route to school, and also the route to Trinity College in the City Centre. Over the month of May, and specifically during Bike Week, workshops were held with pupils where they were facilitated to reimagine their streets to create safer active routes to school and to Trinity College. Pupils will be given the opportunity to present their visions for better routes to engineers, planners and decision makers to influence infrastructure in their own communities. An exhibition of the proposals and designs will be celebrated at venues associated with Dublin City Council and Trinity College Dublin in Autumn 2022.

Learnings from the Bicycle Heroes Workshops are being used to engage with schools with an installed School Zone (SZ). The aim of this is to empower the children to audit their SZ and consider if it is being used appropriately. Feedback from these workshops will inform future communications for Schools, Pupils and Parents.

Handshake Immersive Symposium

Dublin City Council is participating in the EU-funded CIVITAS Handshake project. The project involves thirteen cities collaborating on over 60 measures across 23 different types of solutions, which are designed to make cycling a more attractive everyday mode of transport. As part of this project, Dublin is being mentored by Amsterdam and the 2 cities took part in an immersive symposium in Dublin from the 22nd - 25th of March.

Nine experts travelled to Dublin for the symposium with a 10th joining remotely. Ten sessions were delivered during the week plus a recreational city cycle for staff and delegates. Participant numbers were approximately 300 for the week and included DCC staff and Councillors and representatives from the NTA, HSE, Green-Schools, PPN, TUDublin, Businesses, Dublin Cycling Campaign etc. Sessions included the History of Cycle Policy in Amsterdam, Cycling and the Media, Cycling and Business and a dedicated session for Councillors on Engaging the City. Participation in the Symposium was high with many opportunities for interaction and networking.

Delegates attending the CIVITAS Handshake Immersive Symposium requested ongoing collaboration and receipt of updated information on School Zones design development and associated community engagement and behaviour change initiatives. A site visit to participate in a cycle bus was arranged at the request of delegates to gather information and contacts for a case study on School Zones.

Councillor Study Visit to Amsterdam

As a result of conversations which took place in the lead up and during the Handshake Symposium, a Study Tour in Amsterdam was organised. The Lord Mayor and a group of 9 Councillors and 4 Officials travelled to Amsterdam for 2 days at the end of May to learn more about the City's cycle policy and experience the infrastructure in person.

Bike Week 2022

Bike Week was launched by the Lord Mayor in Eamonn Ceannt Park, Crumlin. The Bike Hub Crumlin is a new service coming soon to Eamonn Ceannt Park that will provide accessible cycling to people with disabilities and older citizens, along with bike workshop training for young people, upcycling of second hand-bikes for DEIS schools and Direct Provision Centres, and cycling training for women and other groups. Activities for Bike Week took place from 14th – 22nd May and were carried out by the Environment & Transport Department, DCC's Sport & Wellbeing Partnership, as well as a number of schools and community groups through DCC's Community Grant Scheme to support groups to organise cycling promotional activities in their local area. Bike Week activities included cycle training, bike maintenance workshops, community cycles, cycle to school / work promotions, cycle safety sessions, webinars and more. DCC's flagship Bike Week event was a family-friendly bike festival which took place in Fairview Park on Sunday 22nd May and included cycling obstacle course for children, bike demonstrations, bike maintenance, bike parade, trishaw tours, children's workshops including story-telling, yoga, pedal-powered activities.

Our flagship event Pedalpalooza, a family-friendly cycling for all festival, took place on Sunday 22nd May in Fairview Park. The event was very well attended with approximately 2,500 participants engaging throughout the 4-hour event.

In addition, Dublin City Sport & Wellbeing Partnership, delivered a number or activities in schools and communities throughout the week and funded communities around the city to host their own bicycle focused events.

The Active Travel (AcT) Programme – Walk-Wheel-Cycle Network

The Active Travel Programme Office continues to increase staff resources with the addition of a new Senior Engineer, a Senior Resident Engineer, an Executive Architect and a Senior Executive Planner during August. The office continues to engage with our Human Resources section on the recruitment of additional personnel.

There is an emphasis on the rapid development of safer facilities on the core walk-wheel-cycle network. The team working on the delivery of interim schemes is headed by a Senior Engineer. To date, assessments have been completed on seven corridors. The design of interim measures for segments of these corridors is now underway. The detailed proposals will be presented to the relevant Area Committees during September and October 2022. This will be followed by non-statutory public consultation.

These seven interim schemes are:

- Suir Rd to Thomas St via James Walk, Forbes Lane, Marrowbone Lane & Thomas Court
- Kimmage Rd West to Clogher Rd via Lorcan O Toole Rd, Stannaway Rd, Sundrive Rd & Rutland Ave.
- Tonglegee Rd, Kilbarrack Rd, Oscar Traynor Rd.
- Ratoath Road & Cappagh Rd
- Howth Rd, from Station Rd to James Larkin Rd
- North Circular Road
- Merrion Square West, Ely Place & Hume St

In addition, the tender documents for delivery of the remaining sections of the interim Liffey Cycle Route, comprising Eden Quay, George's Quay, Burgh Quay and Aston Quay are being finalised and will go to tender for construction during Q4 2022.

The construction of the Clontarf to City Centre Project is progressing well and works will be scaled up from this September following the implementation of the diversion of some of the city bound traffic from Annesley Road, North Strand Road and Amiens Street. This will allow for the opening up of additional work fronts. The contractor has worked a number of weekends and as the project progresses, more weekend works are planned. For reference, the contractor's normal working hours are Monday to Friday between 08.00 hours and 19.00 hours, and Saturday between 08.00 hours and 16.30 hours.

The works on the Grand Canal Scheme are also progressing well. The contractor is currently working on the diversion of gas mains.

The National Transport Authority has approved Royal Canal Phase 3 to proceed to construction. The Active Travel Programme Office will be finalising the contractor selection process during this month. In addition, works on the Dodder, Herbert Park to Donnybrook are also planned to commence later this month. A communication plan for the projects proceeding to construction will also be implemented. This will include a leaflet drop to local residents and businesses.

A number of permanent schemes are at various stages of planning and design. A detailed update on these will be provided in the quarterly report to be issued next month. The Active Travel Office presented to members of the Local Area Committees for the Central, South East and North West areas in July. The presentations covered the overall Active Travel Network and specific schemes for these individual areas. There are plans to present to the two remaining Local Area Committees in September.

Water Bottle Filling stations

To support the move to reduce single use plastics DCC are developing a programme to install water bottle filling stations at key locations around the city. The first of these filling stations has been installed as part of the Clarendon Row Public Realm scheme and is now operational. Further outdoor filling stations will be rolled out around the city as part of future area improvement schemes. Bottle filling stations are also currently being fitted at Libraries in Ballyfermot, Walkinstown, Coolock, Cabra. Raheny and Pembroke.

Sustainable City Centre Strategy

The Covid-19 Crisis and the changes that it has brought to the city and its likely knock on consequences on the city's transport needs and the overall mobility movements in the city require that the existing City Centre Transport Strategy document be updated. This will require DCC to both look at the pattern of mobility in the city pre Covid-19 and what is now needed for the next number of years.

In addition projects such as Metro link, Bus Connects, Dart +, Luas extension to Finglas and the increase in cycling funding allocation will require a coordinated view of how these projects will work together and what is required over the next 5-6 years. The Council is also working with the three other Dublin Authorities, SMART Dublin and the CARO to publish an overarching electric vehicle charge point deployment strategy within the context of our sustainable urban mobility strategy and the Government's vehicle electrification targets.

Environment & Transportation Department Input to the Development Plan Review

Transportation Planning Division (TPD) supports the Planning Authority in carrying out its statutory Forward Planning and Development Management functions. In 2022, the main Forward Planning focus continues to be the review of the 2016-2022 Dublin City Development Plan which commenced mid December 2020. The review takes up to 2 years and will conclude with the adoption of the final City Development Plan 2022-2028 towards the end of 2022.

Transportation Planning Division has direct responsibility for writing the Sustainable Movement & Transport chapter and supporting appendices, guidance documents and standards in consultation with all of the relevant divisions across Environment & Transportation Department. Transportation Planning also has responsibility for the preparation of relevant maps and graphics.

The Draft Development Plan is now entering into the final 6 months of preparation, with the final Plan due to be approved at the end of November 2022, and effective from 24th December 2022.

Following the end of public consultation for the Draft Plan in February 2022, a Chief Executive (CE) Report was issued to the Elected Members for their consideration on the 29th April 2022. Over 500 motions from the Elected Members were received by the 27th May 2022 and Transportation Planning, together with the Planning Department, are currently reviewing these motions and preparing responses to same. This report will be completed by the end of June 2022 and presented to the Elected Members during a series of Special Council Meetings in July 2022.

Subject to any amendments arising from the motions adopted during these Special Council Meetings, a further period of public consultation (Material Amendments) will commence on July 27th to 1st September 2022. A further CE Report will be prepared in September following the public consultation, October will see a period for consideration of said report by the Elected Members and further Special Council Meetings will occur in late October/early November.

Following the making of the Development Plan in November, December will also see extensive work being required to be carried out by Transportation Planning Division (and the Planning Department) in the preparation of all documents and associated mapping to ensure that a fully complete Written Statement and Maps are available for publication before Christmas 2022.

Q1 2023 will see the Planning Department reviewing all the policies and objectives in the new Plan that require action. These will be assigned to the relevant division/department in DCC to be designated as projects for commencement/completion within the lifetime of the Plan. It should be noted that there are a number of objectives that will fall within the remit of the Environment and Transportation Department. Transportation Planning Division will also be consulting with the Planning Department in any forthcoming Area Plans or studies that arise from the new Development Plan.

Culture, Recreation & Economic Services

New Policy/Strategy

Proposals to develop a Dublin City Sports Plan will be presented to the Arts Culture Leisure & Recreation SPC in September. The Plan will include a strategic review of sports policy, programming & infrastructure. Sports & Recreation have carried out a thorough mid-year review of the Sports Capital Programme within the context of funding, significant inflation, availability of professional services, supply chain delays and compliance with strict procurement procedure. An update on current significant projects and realistic timeframes for development and delivery is provided in Department Projects update below. Our priority is to deliver these projects in 2022/23 and that future sports capital programmes will be developed within the context of the Dublin City Sports Plan as highlighted above. The timelines provided are based on information to hand and subject to market responses to Invitation to Tender when issued.

Departmental Priority

Local Economic and Community Plan 2022-2027 (LECP) will be developed via a six stage process and regular updates will be provided.

Economic Development & Enterprise SPC Next meeting to be held on 6/9/22, preparatory work underway.

Dublin Regional Enterprise Plan 2024 was launched on 1/4/22 by the Dept. of Enterprise, Trade & Employment. 20/26 actions will be led/supported by DCC individually or in collaboration with other stakeholders. An implementation meeting was held on 20/06 where an update was provided on progress made, with a focus on 2/20 actions which are progressing well — Enterprise Hub Provision & Brand Vision for Dublin with two workshops held that will inform a strategy for the Dublin Place Brand https://bit.ly/3JtyNAZ

Night Time Economy Strategy Preparatory work has been completed on the development of A Night Time Economy Strategy. The EDE SPC Summit Series 2022 will focus on the Night Time Economy.

Dublin Belfast Circular Economy Capital Expenditure Feasibility Shared Island Funding An application was made to the Shared Island Fund on 02/06, seeking funding for a joint initiative between DCC and Belfast City Council for a feasibility assessment to create a Connected Circular Economy on the Island of Ireland. They have confirmed that the application was received by the deadline and that it is being reviewed.

Trading Online Vouchers (TOV) in 2022: The scheme has approved 137 applications and the current value of TOV approvals in 2022 is €289,694.

Feasibility, Priming and Expansion Grants approvals in 2022: To date 35 grants approved to the value of €890,000 supporting the creation of 76 employment opportunities in the Dublin city economy this year.

Training: 2494 participants attended 125 training courses from 1st Jan – 31st July 2022. Annual target 3,000 participants.

Mentoring: 623 hours of mentoring were completed from 1st Jan – 31st July 2022. Annual target 1,000 hours.

Start Your Own Business: 217 participants attended 8 courses & 1 boot camp from 1st Jan – 31st July. Annual target 227 participants & 13 courses.

Filming Update 164 Production applications completed by 11th of August 2022 Productions include TV and Film from, Commercial productions include; BT Young scientist, Joe.ie, Bolt, Regatta and Slainte Whiskey. TV and Movies include; The Clean Up Crew, Kin, Northern Lights, Flora and Son, Who do you think you are?

Dublin Sportsfest 2022 DCSWP is currently in the planning stages for the fifth year of its citywide flagship event. Sportsfest is a week-long celebration of sport and physical activity and will coincide with European Week of Sport from $23^{rd} - 30^{th}$ September.

Swim Officer: Dublin City Council and Swim Ireland have appointed a 'Get Dublin City Swimming' Officer. The role requires delivery of a targeted integrated swimming programme across the city.

My Open Library launched at Pembroke Library in August. In an extension of the existing service, library users who register for My Open Library can now access the branch from 8 am to 10 pm, 365 days a year. This initiative is in addition to existing staffed hours at Pembroke Library which remain unchanged. More information about registering for the service is on the libraries' website at https://dcpla.ie/my-open-library

All children starting school for the first time this September are invited to collect a free First 5 Little Library book bag and join their local library. Read more in our blog here.

The **Creative Studio** is a free to use digital maker space for music recordings, podcasts, videos, digital stories and oral histories. At the centre of this space are two recording booths providing with access to a variety of audio and video recording equipment and software. More information on the service is available here.

The Children's Library in **Kevin Street Library** has reopened following essential works to install a new fire escape, including the planning of a new escape route from the site on to the street.

As part of the Dublin City Council Parks Strategy and the North East Inner City Greening Strategy, DCC committed to the refurbishment of Diamond Park. Diamond Park closed on 15th August to facilitate the commencement of works. It is anticipated that the works will take approximately six months with the park targeted for re-opening in Q1 2023. The planned works include the following:

Corporate Services, Transformation & Human Resources

Digital Services

During July and August, the Digital Services Team has:

- Added road closure notifications to Citizen Alert service
- Digitised a number of internal processes for HR, Finance, IS and the Law Department on our new intranet communication portal CitiDesk. The objective is to replace all paper based internal process with automated workflows.
- Prepared consultation survey and video to begin public consultation on draft digital strategy
- In conjunction with the Transformation Unit have begun rolling out the online appointment booking system to allow citizens and businesses book either in person or online meetings

Transformation Unit

During July and August, work on service transformation project has continued including:

- Preparation for launch of the new online customer booking system for DCC venues
- Procured a framework for service designers to facilitate the development of services that are accessible, inclusive and citizen centred
- Continued to work with the Traffic Department on a review of TAG, and with Housing Maintenance on the continued development of the housing maintenance app and customer improvement service
- Development of a staff recognition scheme

Citizen Hub

- There are now 16 services live on Citizen Hub
- 2 services (Housing Allocations and Telecommunications Infrastructure Licence) are for registered users only
- 14 service requests are available for use by citizens and for staff to log on behalf of customers (Short Term Lettings Forms 15 and 17; EV charging)
- Number of new registered users 23rd June to 22nd August 2022: 1,870
- Total number of registered users: **9,693** (9,580 have registered on the 'Self' site and 113 people have registered through 'Service' with a Customer Services Agent)
- Proposed next services to Go Live: Graffiti, Community Clean-Up, Illegal dumping, Abandoned Vehicles, Clean Your Street; other proposed services are Air Pollution, Noise Pollution and DFB complaints

Customer Services

The use of email as a customer contact channel continues to grow. This month's emails principally related to Housing matters, and emails from EPA relating to service requests. The EPA emails have significantly increased, however this is likely to be as a result of the closure of the Fix Your Street system.

Scheduled appointments and drop-in services are being provided for customers for Parking Permits and the Cash Office, and for all other services provided by Customer Services. The number of drop-ins to the Reception desk is increasing.

Improving Customer Experience

- Work is continuing on the development of a new Parking Permit System to facilitate online applications
- Work is ongoing in relation to bringing in real time payment system for customers wishing to pay for Parking Permits
- Preparatory work is underway to commence processing parking permits for Havelock Square in September 2022, with letters due to issue to customers, from Parking Enforcement on 5th September
- Work is starting with the LGMA for a customer experience survey for customers of Housing Maintenance
- Customer Services are looking into a customer experience feedback system utilising links on the current email system
- Working on the development of a new Customer Action Plan
- Developing staff training on introduction of JAM card across DCC services. JAM Card allows people with a hidden disability or communication barrier to tell others that they need extra time and understanding in a private and easy way.
- Working with Crohn's and Colitis Ireland on the introduction of NO WAITING card

The Digital Twin project aims to engage the community, enterprise and other stakeholders of Dublin in an innovative collaboration to explore stakeholder and community engagement with Digital Twin technology. The Smart D8 project is a testbed for innovation, collaboration and engagement in Dublin 8 and aims to explore the new technologies and pilot innovative health and wellbeing solutions to improve quality of life and address challenges facing local communities in the area.

Shared Staff Mobility Service: Next Steps

The Smart Mobility Hub pilot project was an initiative funded under Enterprise Ireland's Small Business Innovation Research (SBIR) programme. Launched in 2018, and supported by UCD, it offered Dublin City Council the opportunity to develop and test a shared vehicle service for staff to use for work-related travel.

The pilot project comes to a close in August, and in collaboration with the three other Dublin Local Authorities, DCC will now conduct a market sounding exercise to

understand what shared vehicle and bike services are currently available on the market. It is the intention of all four Councils to use this opportunity to explore whether a longer term service should be put in place, and in what form. Academy of the Near Future

Academy of the Near Future (ANF) is developing plans for the next phase of school outreach, which consists of a 3 workshop model exploring citizen science with Transition year students. As part of the programming, students will be facilitated to initiate an action project around 'Active Travel' - a core focus area in DCC.

Since being <u>selected as a pilot city</u> to implement the Digital Rights Governance Framework in May, ANF has begun with the <u>Cities Coalition for Digital Rights</u> - a UN-Habitat initiative committed to enhancing citizens' digital rights. As part of this collaboration, a two-part workshop has been held to explore the challenges and opportunities facing Dublin as the city pilots the framework. One of our first outputs from this collaboration is an <u>educational video</u> exploring ethics, privacy, and digital rights in the city.

Open Data Climate Action Challenge

The Open Data Climate Action Challenge launched in April this year, seeking innovative ideas and applications that use open data to drive and support climate action. The competition, organised by Smart Dublin and partners across the Dublin local authority sector including Dublin City Council, Dublin CARO and Codema, has 7 shortlisted, potentially impactful projects participating. All employ open data to support climate action, and operate across a range of priority areas, including: biodiversity, energy, flooding and transport. The Open Data Climate Action Challenge wraps up with a final event on September 14 in which all participants showcase the tools and applications they've developed to stakeholders and the wider public.
