### Item 3

# Motion in the name of Councillor Nial Ring

That the Central Area Committee agrees to instruct the Area Manager to provide Councillors and local residents with a detailed report on how the decision was made to unilaterally change the incoming bus lane at North Strand to a full 24 hours, 7 days a week facility, while at the same time removing a motoring lane and preventing local residents from driving towards the city. The foregoing major restrictions and impositions on local residents in North Strand and Ballybough, as well as on private motorists, could have been alleviated/mitigated somewhat by a reduction in the bus lane times to rush hour only. However, for some reason which has been interpreted as a "don't care" attitude of DCC officials, the exact opposite was done and local residents want to know how and why these decisions were made without prior consultation with them.

from circulation, resulting in a positive impact on the environment, waste reduction and less cost for business.
