Monthly Local Fund Statement

Background

Attached for consideration by the Elected Members in this November 2022 Council Agenda is the Local Fund Statement for the period 27th August 2022 to 30th September 2022. Information is provided on:

- Monthly receipts and payments for current period and same period last year.
- Cumulative receipts and payments for current year and last year.
- Details of main receipting areas and receipts over €1m for the current month and same period last year.
- Details of payroll payments and non-pay payments over €1m in the current month and same period last year.

Overview

Over the period 27^{th} August 2022 to 30^{th} September 2022 Dublin City Council made payments to the value of $\in 139.6$ m. Dublin City Council receipted $\in 183.2$ m of funds with a surplus of receipts over payments of $\in 43.6$ m moving to a net credit balance at period end of $\in 29.8$ m. This value of $\in 29.8$ m is the maximum value applicable, as it includes the full value of payments made whether cashed or not. As at 30/09/2022 Dublin City Council had placed $\in 227.2$ m on investment. The net transfer *from* investments and refundable deposits was $\in 72.7$ m.

There were 5 weeks in September 2022 and 4 weeks September 2021.

Receipts

During the period Dublin City Council receipted €183.2m

€23.3m was receipted from the Department of Housing, Local Government and Heritage during the period as follow

- €13.3m for Social Housing Current Expenditure Programme AHB Leasing and LTL Direct Lease Agreements
- €7m for Voluntary Housing Bodies CALF. CAS and CLSS funding
- €1.2m for RAS rents July 2022

€9.3m was receipted from the other local authorities during the period including:

- South Dublin County Council €1.8m for August for Dublin Fire Brigade
- Dun Laoghaire Rathdown €2.9m for August and September for Dublin Fire Brigade
- Fingal County Council €3.8m for August and September for Dublin Fire Brigade

€3.1m was receipted for Parking Meter Fees, including 7 weeks tags and mobiles compared to 5 weeks from the same month in 2021.

€3m was receipted from Irish Water including €2.5m for Payroll, CMC Pension and CMC costs for August 2022.

€4.8m was receipted from Department of Rural & Communications Development, €3.3m for NEIC Task Force for North Inner East Inner City initiative project and €1.5m for SICAP funding for Social Inclusion and Community Assistance Projects Q4.

€8.1m was receipted from National Transport Authority including €4.1m for Belmayne Main Street and Avenue scheme and €2m for Clontarf to City Centre scheme. €1m was receipted from Tular Property Company as a financial contribution in Lieu of Part V units at the Veterinary College, Ballsbridge.

Payments

During the period Dublin City Council made payments to the value of €139.6m.
