Based on the assessment of the TAG Area Engineer, the Area Engineer does not recommend Double Yellow Lines. On several site visits the Area Engineer observed illegal parking - vehicles parked on the footpath or opposite a continuous white line or within 5 metres of a junction. Under the Rules of the Road (Road Traffic (Traffic & Parking) Regulations, 1997), any illegal parking should be reported to the local Garda Siochana or Dublin Street Parking Sevices at www.dsps.ie or call 01 602 2500. In order to reduce commuter parking, residents and commercial premises can organise a ballot to vote for a Pay & Display and Permit Parking to be installed. Once greater than 35% of residents are in favour of a Pay & Display and Permit Parking scheme, they can apply to Dublin City Council for the implementation of a scheme at https://www.dublincity.ie/residential/parking-dublin-city-centre/start	ı	21/08/2019 1

Based on the assessment of the TAG Area Engineer, it is recommended to install 2 x 5.0m sections of Double Yellow Lines (RRM 008) on both sides of the dished entrance on Walkinstown Green. By installing Double Yellow Lines to both sides of the dished entrance on Walkinstown Green, it may help to make this entrance more obvious to the drivers who are parking adjacent to the entrance. It is not recommended to install any parking prohibitions or restrictions at, or in front of, the dished entrance as it is already covered under law. Any illegal parking should be reported to the local Garda Siochan or Dublin Street Parking Services at www.dsps.ie or call 01 602 2500 for enforcement. STAT: On the northern (concrete) carriageway of Walkinstown Gree, at the dished footpath which is located 35 metres north-eas of Lamp Standard 43357, install Double Yellow Lines (RRM 008), beginning at the western edge of the dishing, extend in a south-west direction for 5.0 metres. There is only one collision recorded for St. James' Avenue - this is the joy-riding collision the customer discribed. Regarding traffic calming measures - the road is too short to qualify for the installation of speed ramps i.e. the road is less than 200m and there is little evidence that traffic calming is required on a regular basis on the road.		12/04/2022 2
5	7027793	Parking Restrictions	SOUTH CIRCULAR ROAD (SC)	Dublin 8	parking on foothpaths	Not Recommended	Based on the assessment carried out by the TAG Area Engineer, the vehicles parked on the private landing in front of the shops are not within the jurisdiction of Dublin City Council and therefore Parking Enforcement cannot enforce any penalties. However, vehicles parked on the footpaths surrounding the landing are parked illegally as Dublin City Council is in-charge of these footpaths and can therefore enforce penalties - see Road Traffic (Traffic and parking) Regulations 1997, Article 13. Based on the assessment of the TAG Area Engineer, it is not recommended to install staggered islands or raise the speed ramps that are already in-situ. As observed by the customer, there is illegal and 'inconsiderate' parking on the road and footpaths 'which is blocking people with mobility issues'. Also, note that driving at 80kph to 'test' the speed ramps is breaking the law as the road has a speed limit of 30kph. If people parked their vehicles legally on the road and observed the rules of the road (Road Traffic (Traffic & Parking) Regulations, 1997), this would create a natural staggered effect and drivers would natrually drive more slowly in order to navigate around the parked vehicles. Also, by parking on the road, and not illegally parking on the footpaths, pedestrians, children, the elderly and people using wheelchairs, buggies and prams are able to move around safely. The Area Engineer visited the location and observed no obstruction to the vehicles turning from Kylemore Road onto Bluebell Avenue. In one instance, a driver on Bluebell Avenue had stopped their vehicle beyond the Traffic Signal Stop line. 10	7029557	Disab Park Bay General	LAMB ALLEY (SC)	Dublin 8	Disabled bay on lamb alley or back lane	Not Recommended	Based on the assessment of the TAG Area Engineer, installing a General Disabled Parking Bay is not recommended on Lamb Alley, Back Lane of John Dillon Street. The Area Engineer, on a site visit, oberved that Back Lane has Double Yellow Lines installed along both sides of the road, and therefore, a Disabled Parking Bay cannot be installed on this road. The Area Engineer observed that there are some parking spaces available on John Dillon Street and ample parking spaces available on Lamb Alley. The uptake of permits to Pay & Display parking is less than 80% on these roads, hence there is not an immediate requirement for a General Disabled Parking Bay. Note that a person who has been assigned a 'Blue Badge' is entitled to free parking in any Dublin City Council Pay & Display parking area. The customer does not specify where they think would be a favourable location for a disabled parking bay or if there is a specific requirement that the Customer would deem to be met by installing a General Disabled Parking Bays in the area.
