## Naming & Numbering Proposal for a new residential development on the site of 63, 65, 65A, 67 & 67A Collins Avenue East, Dublin 5. DCC Planning Ref: 2934/21Sub01 – Condition No 6. 1-67, Easra Court, Collins Avenue East, Killester, Dublin 5.

This is a new residential development by MKN Property Group, on the site of 63, 65, 65A, 67 & 67A Collins Avenue East, Dublin 5. Planning permission has been granted to demolish the existing block and to construct 67 apartments over 1 ground floor retail unit with car parking to the rear. The development is indicated on the attached drawing <u>SM-2022-0544</u>.

Two names were submitted to Dublin City Council, "Easra Court" and "Farran Hall" for this development. The Heritage Officer recommends approval of the name "Easra Court". The Irish translation has been supplied by DCC's Irish Office in conjunction with Brainse Logainmneacha.

The proposal is as follows:

## 1-67, Easra Court, Collins Avenue East, Killester, Dublin 5 / 1-67, Cúirt Easra, Ascaill Uí Choileáin Thoir, Cill Easra, Baile Átha Cliath 5

This has been suggested as a naming option for the new development because the townland name Killester derives from "Cill Easra" which is generally taken to mean the "Church of Easra". Therefore, it is believed appropriate to reuse this local name for the development to further link it with the landscape.
