Litter Hotline/CRM

In addition to the CRM incidents, the Public Domain crew carry out inspections of their assigned routes on a daily basis. Collecting any dumped bags/materials which is not reflected on the above figures.

The total tonnage of collected illegally dumped items from our four vehicles was:

• **17.4 tonne** for December 2022. All receipts were not submitted at the time this report was submitted, a revision is expected in net months report. There was an additional 8.38 tonne collected in November that was not reported at the time. Resulting in November's tonnage as being 46.46 tonne. Revised Total Tonnage for 2022: **432.43 tonne**.

Overtime was carried out **3** times for a mixture of standard waste removal and concentrated Community clean up removal.

Community Clean-ups

Community Clean up equipment was distributed to **24.** Community Groups / individuals between 1st December – 23rd December. Requests for the removal of bags from community clean ups were handled by Waste Management and Public Domain staff.
