Current Projects in the area

Belcamp B

The project has stage 2 approval and Part 8 granted. Currently preparing stage 3 application submission to the D.H.L.G.H. Contractor expected on site Q2 2023. It has been confirmed that this project will be taken over by an Approved Housing Body.

Glin Court

The redevelopment of Glin Court went for stage 4 approval, to the DHLGH, on January 6th 2023. It is expected to have the contractor on site in March. Residents and local Councillors were invited to an open evening in the Glin Centre, on 9th February, to view the plans. The contractor should be on site spring 2023 with completion expected in October 2024.

Presently, a review is commencing on the tender documentation before the issuing of the tender for the appointment of a contractor to construct the new housing scheme. The project is for the full demolition of the existing two of the three housing blocks and the construction of 32 new homes for Older Persons.

Cromcastle Underpass site

Feasibility stage, design team appointment. The LDA are beginning the consultation process on Cromcastle Project. The consultation process will run until March 2023, for the public and all interested stakeholders to partake in.

Cromcastle Court / Woodville

The regeneration of the first phase of Cromcastle Court and the Coal Yard site has Stage 1 approval. The proposal is for the demolition of three of the existing housing blocks on the Cromcastle Court site and for the construction of a new housing scheme in its place and the redevelopment of the Coal Yard site. The current proposals show for 116 homes on the Cromcastle Court site, a mix of one, two and three bedroom homes, while it is planned to provide for 34 older person homes on the old Coal Yard site

A design team has been progressing with design proposals and are currently working towards the pre-Part 8 process.

Upon receipt of Stage 2 approval from the D.H.L.G.H., it is intended to lodge the Part 8 planning permission.

Further consultation with residents and the local community is planned to take place early 2023.

Bunratty Road

We are awaiting a revised programme and completion date from the Contractor. Expected handover will be phased, Q3 2023.

Oscar Traynor

Planning Application was submitted on 21st December 2022 as an LSRD (Large Scale Residential Development) application to the Local Authority. A decision is due to be made by end February with final grant due by end March 2023. This is subject to delays arising from potential requests for further information, appeals to An Bord Pleanala, Judicial Review challenges, etc. In the event of a Full Grant of Planning in March and no subsequent challenges (as outlined above), construction of Phase 1 will commence by the end of this year with Phased delivery to the end of 2027.
