## **Ballymun Social Regeneration Fund 2023**

A report presented to the Chairman and Members of the North West Area in September 2022, Item No. 17 on the Agenda, recommending that the maximum amount of funding that can be used for staff resources, programming and general administration costs in 2023, remains at 75% for existing recipients of the fund and new applicants must allocate a minimum of 50% of funding to programmes (excluding salaries, wages and overheads) with the exception of specialised services, this was subsequently approved and implemented by the Ballymun Social Regeneration Fund Assessment Panel.

A sum of €1,725,000 was allocated to the Ballymun Social Regeneration Fund for 2023. This funding is to continue to support the process of social regeneration in the area. The social regeneration objectives for Ballymun are set out in Sustaining Regeneration – A Social Plan for Ballymun. Applications for the 2023 fund closed on December 16th 2022. 21 applications in total were received. The total amount of funding applied for was €2,068,225, which is €343,225 over the allocated budget of €1.725m.

The Assessment Panel met on January 9<sup>th</sup>, 12<sup>th</sup> and 19<sup>th</sup> 2023 to consider each application/programme proposed under this fund to ensure that the criteria as stipulated was met, all supporting documentation was in order and the service provision outlined in the work plans is in line with the objectives as set out in Sustaining Regeneration – A Social Plan for Ballymun.

There were two unsuccessful applications as they did not meet the criteria.

19 organisations/groups had funding approved by the Assessment Panel for 2023 as outlined below. A portion of the fund was withheld to provide additional support services to the groups and organisations including Training Workshops, exploring funding streams, and Mentoring Services.

Funding is payable quarterly in advance, subject to timely returns of all reports. Annual financial output returns are submitted quarterly for each programme, followed by annual progress reports. As per Clause 5.6 of the Service Level Agreement, any unspent funds paid to the Service Provider must be repaid to DCC within 30 days of the end of the contract period.

In line with the Assessment Panel's objective to provide a support service for Social Regeneration funded groups, 2 workshops on the topic of Governance Training for Charities/Non-Charities were held on Tuesday February 28<sup>th</sup> in the Council Chamber in Ballymun Civic Centre.

Mr. Senan Turnbull, Community, Voluntary & Charities Sector Specialist, who is an independent member of the Assessment Panel delivered the informative presentation outlining the obligations and best practices of charities and non-charities regarding their Governance, facilitated the workshop. The morning session was aimed at charitable organisations and 15 groups were represented – the afternoon sessions was for non-charitable organisations at which 4 groups were represented. The feedback on the sessions was extremely positive and many groups said afterwards the information provided was very valuable.

A report on Ballymun Social Regeneration Funding was also presented to the Finance Strategic Policy Committee on January 19<sup>th</sup>, outlining the background, purpose and scope of the fund as well as the objectives of the Assessment Panel going forward. This report was requested following discussions of possible cuts to the fund during the Dublin City Council 2023 budgetary process.
