Not Recommended	<p>The Area Engineer does not recommend cycle lights to be installed on Finglas Road at the aforementioned location.</p> <p>This section of road forms part of Bus Connects Finglas to Phibsborough Core Bus Corridor Scheme that will support integrated sustainable transport usage through infrastructure improvements for active travel. The junction with Old Finglas Road will be upgraded, including a new controlled toucan crossing. The National Transport Authority will not provide any funding for traffic management civil works that may restrict/conflict with any future designs of the Bus Corridor Scheme.</p>	Member of the Public	17/05/2023	0

Not Recommended	<p>The Area Engineer does not recommend double yellow lines on Shanliss Way at the junction with Shanliss Walk. Currently it's not policy of Dublin City Council to provide parking restrictions where it's already covered under the law.</p> <p>Under The Road Traffic (Traffic & Parking) Regulations, Section 36 paragraph "(2) A vehicle shall not be parked - (c) within 5 metres of a road junction;</p> <p>(k) in a manner in which it will interfere with the normal flow of traffic or which obstructs or endangers other traffic;</p> <p>Please note that instances of illegal parking should be reported to Dublin Street Parking Services, the City Council's parking enforcement contractor (Ph: 01-602 2500 or Email parkingenforcement@dublincity.ie), or to the local Gardaí, as it is a matter for enforcement under the Road Traffic Regulations.</p>	Member of the Public	22/05/2023	0
