Central Area Public Domain Reports

North Inner City

Litter Hotline/Citizens Hub

In the period 1st – 30th November 2023, incidents were reported via Litter Hotline/Citizens HUB for the **North Inner City & Glasnevin / Cabra Area**.

In addition to the Citizens Hub reported numbers, the Public Domain crew for the North Inner City & Glasnevin / Cabra Area carry out inspections of their assigned routes on a daily basis. They collect any dumped bags/materials found, that is not always reflected on the above figures.

The total tonnage of collected illegally dumped items from our four vehicles was:

- **51.09 tonne** during November. Last month's total was 52.26, an additional **5.22 tonne** more than what was reported last month. This brings the total for this year to 464.53 tonne.

NEIC Community Clean-ups

Community Clean-up equipment was distributed to **32** Community Groups / individuals between 1st – 30th November. Requests for the removal of bags from community clean ups were handled by Waste Management and Public Domain staff.

Graffiti Removal

There were **31** requests to remove graffiti during the month of November. Internal staff as well as private contractor PMAC carried out all removals.

Weed Removal

Due to the unavailability of staff, no weeding was carried out during November.

Halloween – Bonfire Material Removal

Following up on Halloween activity, the weight of material collected by Public Domain, Waste Management staff and Contractors across Dublin during the Halloween period was **493 tonne**. That is 52 tonne more than what was collected.

Collection of Leaves

Social media posts and local signage has been put up in the NEIC area publicising the availability of bio degradable bags.


Cabra / Glasnevin

Community Clean-ups

Community Clean-up equipment was distributed to **21** Community Groups / individuals. Requests for the removal of bags from community clean ups were handled by Waste Management and Public Domain staff.

Weed Removal

The Cabra/Glasnevin weeding schedule for 2023, consisted of approximately 100 locations spread evenly across the LEA which accumulated to over 30km in distance.



Leaf Collection Response

Cabra Area Office continues to support and coordinate the community leaf clean-up initiative



Halloween – Bonfire Material Removal

Waste Management Services collected a total of 493 tonnes of bonfire material across Dublin City which included significant stockpiles in the Cabra Glasnevin LEA



Painting Programme 2023

Phibsborough and Carnlough Road were identified as part of the programme with a total of 240 bollards bins and railings painted in Phibsborough and 66 lighting poles on Carnlough Road. New locations to be identified in our 2024 Programme.



Public Domain Projects

Fassaugh Roundabout was power washed, the verges edged and new plants were planted just in time for the Christmas tree lighting event.



Blackhorse Avenue

This location was identified as needing some addition care. Project scheduled to commence in December



Blessington Place Archway

Location identified for power washing and a general clean up. Project scheduled to commence December



Laneway Park Road

Troublesome laneway to be cleared and cleaned after flooding issues reported to Cabra Area Office. Project scheduled to commence December.

Planter to be relocated to the Housing Office and damaged sign to be removed and replaced. Project scheduled to commence in December
