Motions on Notice Dublin City Council Meeting 08th of January 2024

1) Councillor Janice Boylan & Daithí Doolan

Submitted: 23rd February 2021 Replaced: 18th December 2023

Dublin City begins the year 2024 in the wake of the events of 23 November 2023. The cruel attack and injury of three children and an adult at Gaelscoil Choláiste Mhuire and the deplorable rioting and looting which followed, shocked our City.

However, six weeks on, we resolve to continue to build with determination on what is best in our City. The solidarity with those who were injured; the courage and diligence of front-line emergency and other workers, including Dublin City Council workers; the unity in opposition to the far right elements who sought to use the tragedy to stir up hatred; all these positives point to the way forward.

Therefore Dublin City Council resolves to:

- Work with all relevant public bodies and stakeholders, including the Garda Síochána and Government departments, to improve community safety and confidence in all parts of our City
- Continue to enhance our City centre as the hub of Dublin's commerce and culture and to make it a welcoming place for all, both day and night
- Give civic leadership to improve our City for all who live here, in all our diversity, and all who visit.

We note that Dublin City will be made safer if agencies, including Gardaí, youth services, drug services and mental health services work with communities to deliver the change that is so urgently required. To this end Dublin City Council seeks an urgent meeting with the Minster for Justice, the Minister for Transport and the Minister for Health to discuss:

- Establishment of public transport policing on the DART, Luas, Irish Rail and Dublin Bus,
- Improving resourcing to support the work of community Gardaí and an increase in new Youth **Diversion Projects**
- Addressing and seeking to resolve issues which lead to loss of Gardaí from the service in Dublin, such as the cost of living, especially housing
- Increasing funding and resources to drug rehabilitation programmes and mental health services in areas of high demand.

That a pilot "Controlled Parking Zone" be introduced in the inner city area of Dublin 8 where locals are finding it increasingly difficult to park near their homes and businesses. This scheme has been successfully operating in areas of Belfast since 2018 when the council designated over 50% of a defined area's available parking bays to resident only with the remaining bays as Pav & Display. They are clearly colour coded and signage erected to alert motorists to the scheme.

Submitted: 23rd August 2023 That Dublin City Council recognises the representative importance of visual depictions, illustrations and computer generated imagery of new buildings and the regeneration or conversions of older buildings as presented in planning applications. Such representations understanding overall support the public's of the design of the building/renovation/conversion as well as allowing for the aesthetic appreciation of the application. Therefore to allow for greater public engagement with the built environment of our City and to keep the public better informed of ongoing development in our City, Dublin City Council will require either as enforceable policy or as a bye-Law that all commercial sites or commercial buildings subject to the planning application process from submission to building commencement AND during the construction process until full building/conversion/regeneration display full colour computer graphic imagery of the proposed building/regeneration/conversion of significant size (no smaller than 3m x3m) on all visible sides of the building/site and to include a Current Update poster (no smaller than A3 size) to keep the public informed of the status of the planning application process and the construction process.

That Dublin City Council restates its support for the redevelopment of the Smithfield Fruit and Vegetable Market without further delay. That the Council dedicates itself to working with the Government, contractors, architects and engineers to remove any barriers to the progress of the development of this site and to bring it into public use. That the Council recognises the successful development of the Smithfield Fruit and Vegetable Market as providing a crucial amenity to residents of Dublin and as a positive example for the redevelopment of markets elsewhere in the city and that a clear timeline be put in place for the re-development of the market.
